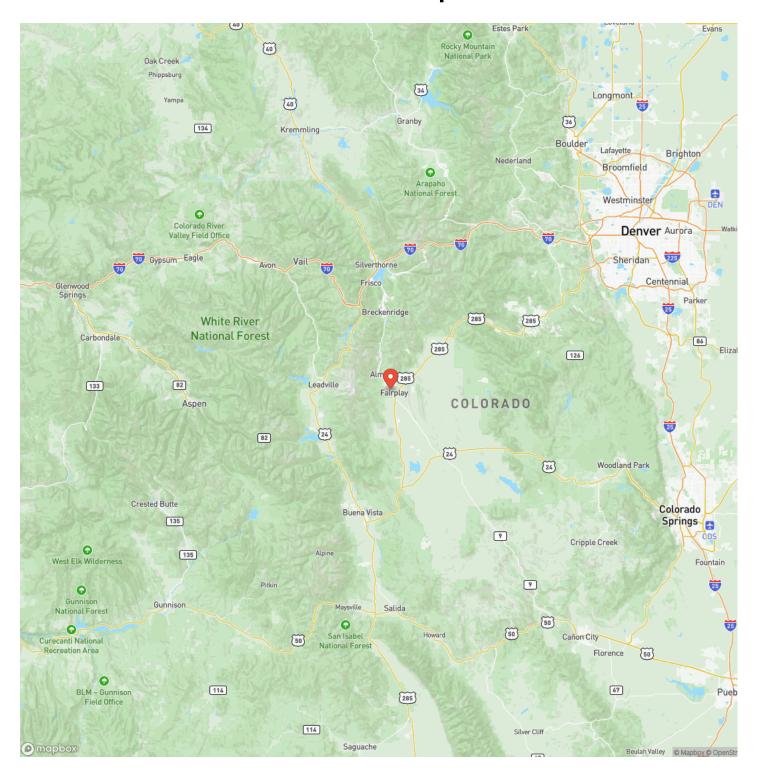


Locator Map



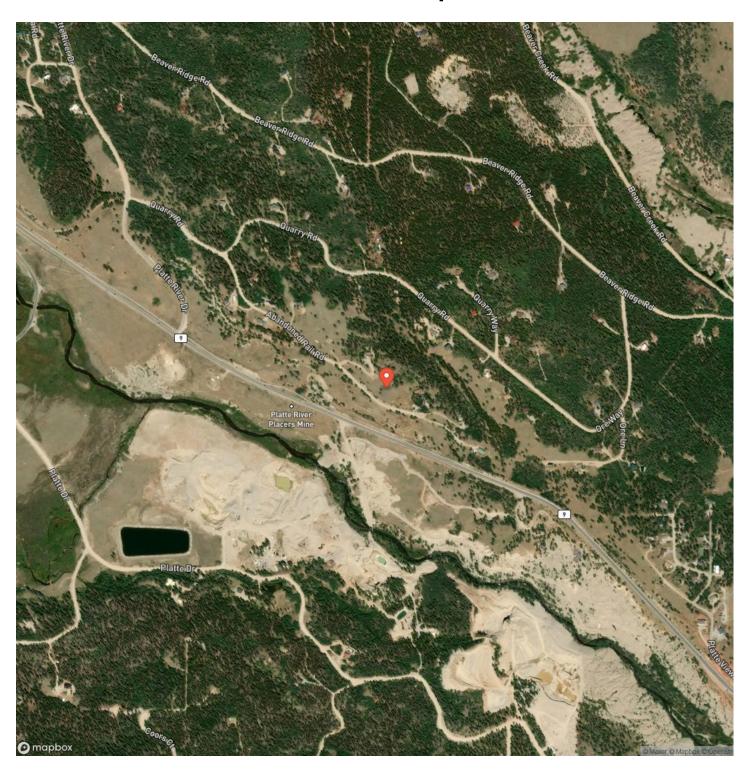
