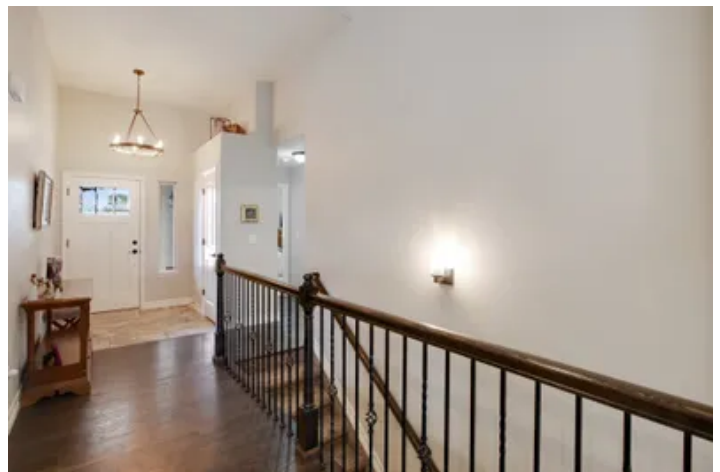

wood flooring. This 5 bedrooms and 3 full bath home with a finished walkout lower level and wet bar is ready for entertaining. The covered patio off

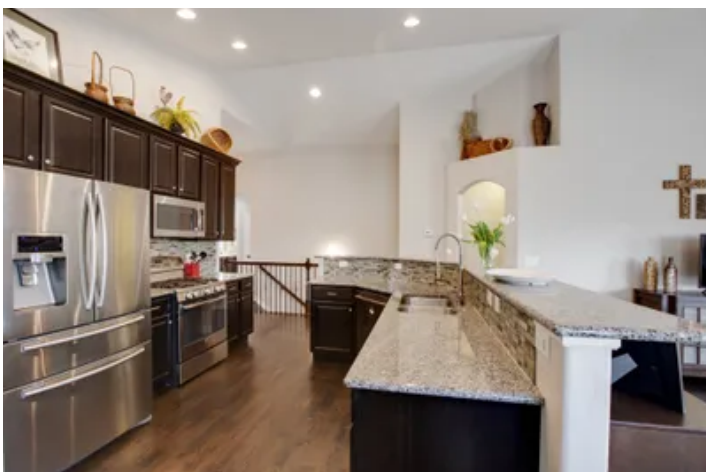
the lower level is surrounded with well presented landscaping and a Green Space. The Ray Berg Open Space with hiking trails is a 10 minute walk and

access to the Smith Creek Open Space preserve is only 1 block away! The Northgate area is within Academy School District 20 which is one of the

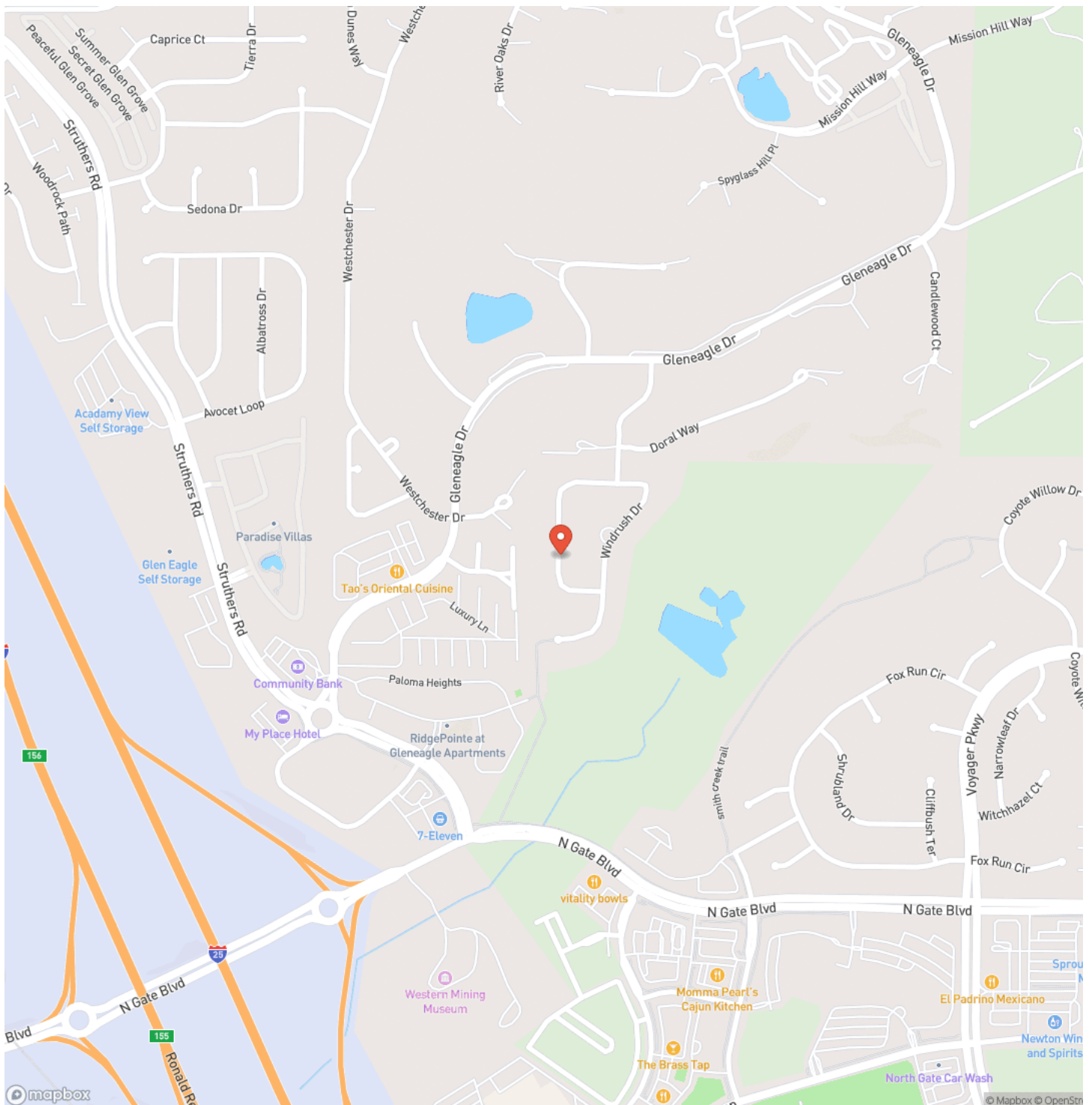
highest rated school districts in the Pikes Peak region. Don't miss out on this beautiful Ranch home only minutes away from the Air Force Academy in

a great neighborhood in Colorado Springs!

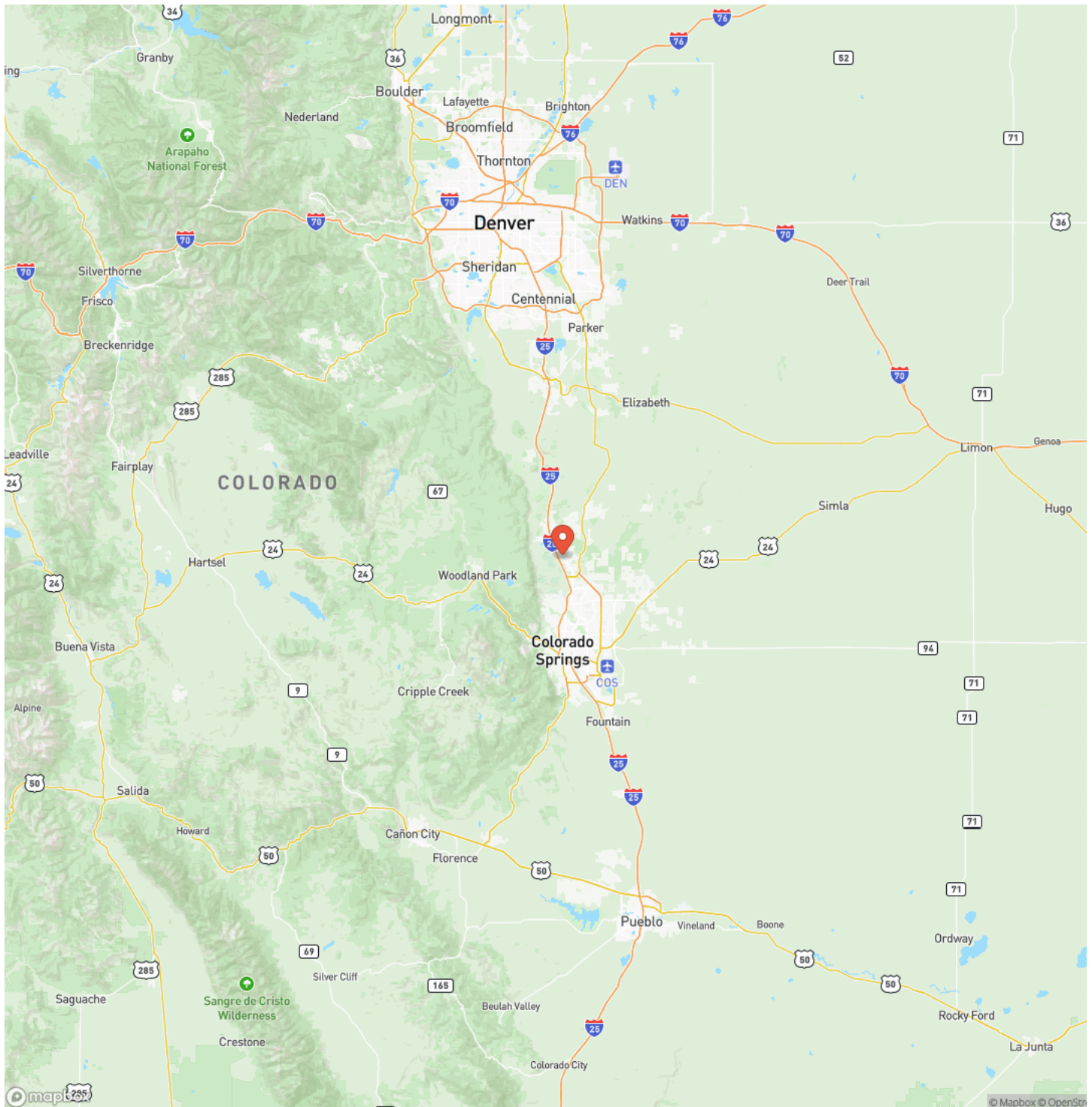




Locator Map
