The home also features 6 bedrooms, 5 bathrooms, oversized 4-car attached garage.

Enjoy working in the 60 x 138 insulated shop/barn. The building features a full concrete floor, six overhead doors, insulated and finished walls and ceilings, a floor drain, interior water hydrant, and water connections in the floor that can service individual horse stalls if desired. The structure also includes a pine finished tack room, large tool room, storage garage area, 220 volt service for a welder, lighted cupolas, and a covered porch. This is a very unique setup that is ideally suited for a small business owner or contractor as well as an equestrian enthusiast, car collector, or hobby shop. The balance of the 20 acres surrounding the building site consists of productive pasture/hay meadow, two ponds stocked with large bass, bluegill, and catfish, an abundant variety of shade trees, ornamental trees, and pine/spruce shelterbelts, a paved driveway, large system of underground sprinklers, and thousands of feet of steel and vinyl horse safe fencing. This property is truly one of a kind considering the quality of construction of the spacious home and outbuilding, the manicured grounds, the large 20-acre parcel, and the close proximity to the Norris School and the services and shopping just minutes away in south Lincoln.

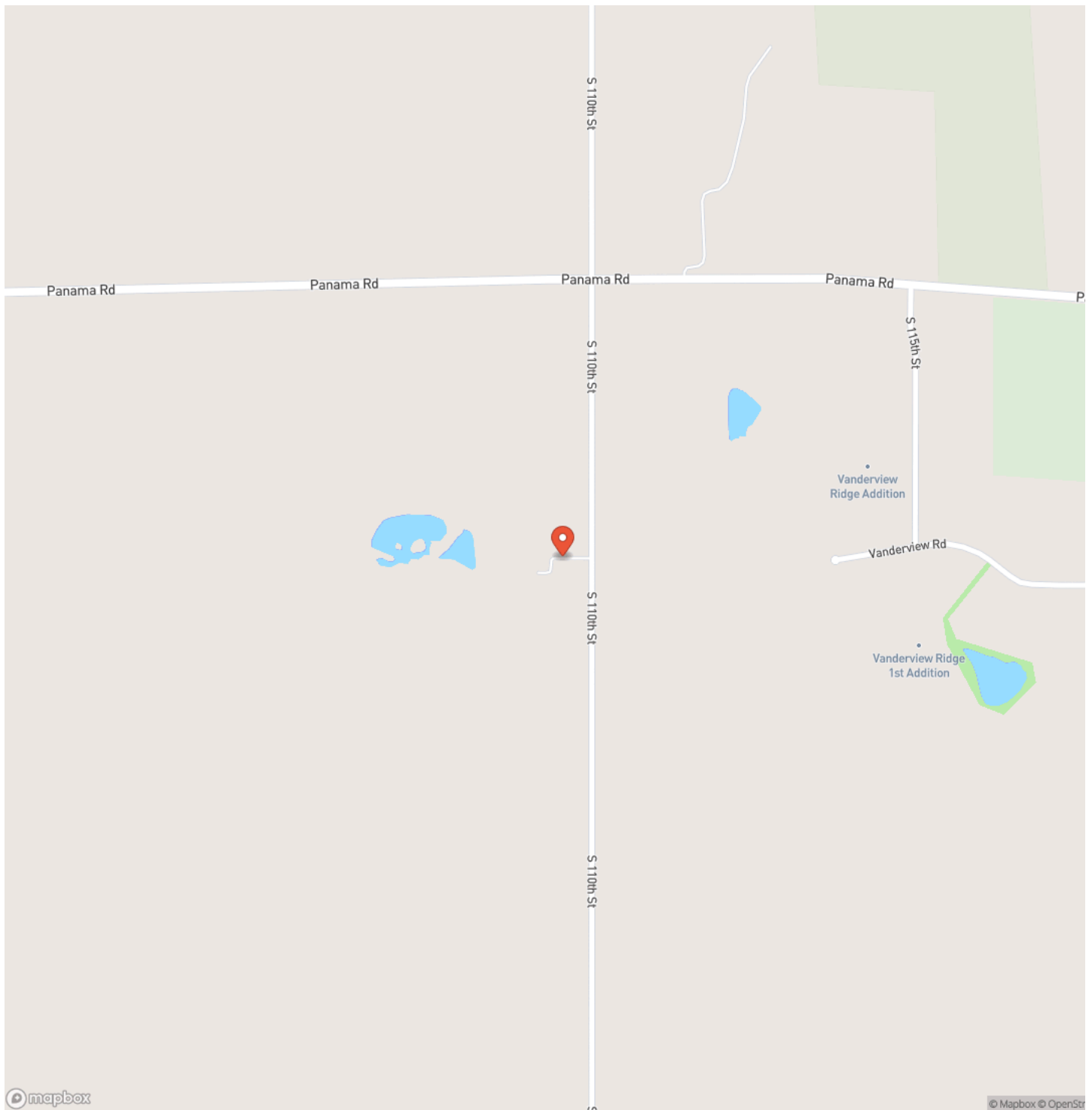

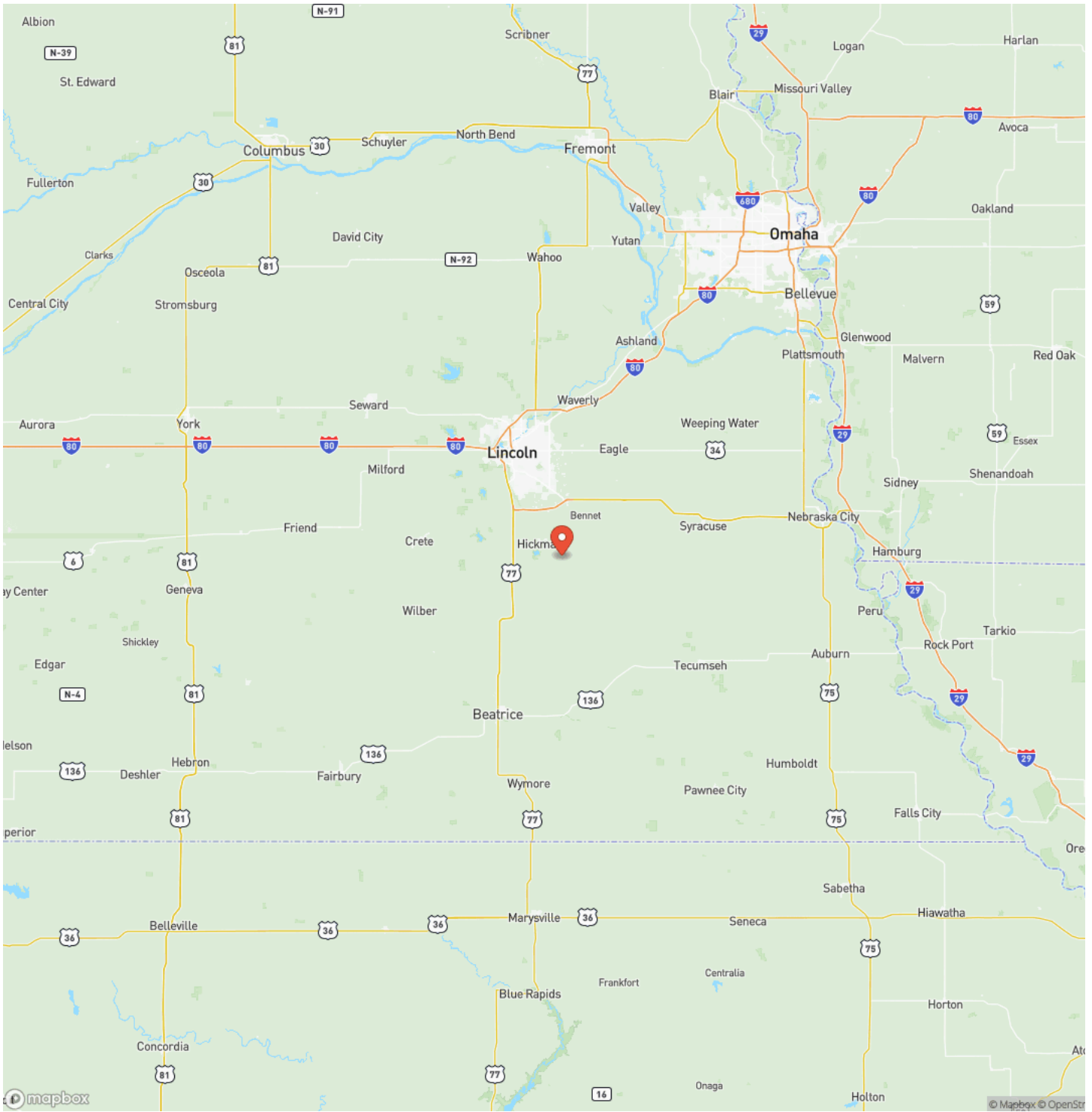
Locator Map
