SURVEYOR'S REPORT

SUBJECT PROPERTY: This survey was done at the request of Mike Andry to perform an original survey of three tracts in the West Half of the West Half of Section 12, Township 2 South, Range 1 East in Liberty Township, Crawford County, Indiana. The record owners are James David and Cathy Lynn Andry with a deed of record found in Instrument #2015R-1381.

In accordance with Title 865, Article 1.1. Chapter 12, Sections 1 through 34 of the Indiana Administrative Code, the following observations and opinions are submitted regarding the various uncertainties in the locations of the lines and corners established this survey as a result of:

VARIANCES in the reference monuments:

Reference monuments and corners from this and previous surveys

NW 1/16 of Section 12, Township 2 South, Range 1 East: Recovered a stone with a "+" in the top and referenced by a steel post.

North 1/16 of Sections 1/12, Township 2 South, Range 1 East: Recovered an engraved stone referenced by a Carsonite marker.

SW 1/16 of Section 12, Township 2 South, Range 1 East: Recovered and engraved stone at a fence corner. A Carsonite marker was driven at the stone.

South 1/16 of Sections 11/12, Township 2 South, Range 1 East: Recovered and engraved stone at a fence corner. A Carsonite marker was driven at the stone.

NW corner of Section 12, Township 2 South, Range 1 East: Recovered an engraved stone referenced by a ½" Primavera rebar..

SW corner of Section 12, Township 2 South, Range 1 East: Recovered a wood post at a four way fence corner.

East ¼ of Section 12, Township 2 South, Range 1 East: Recovered a pipe with a Carr cap. West ¼ of Section 12, Township 2 South, Range 1 East: Recovered a 5/8" Lynch rebar at grade. This corner was calculated on Job #22-111 at the midpoint of the stone at the northwest corner of the section and the four-way fence corner at the southwest corner of the section. The calculated position is North 65 East 18.2 feet of the Lynch rebar. The Lynch rebar was set at the midpoint between stones recovered at the North and South 1/16 corners. The stone at the South 1/16 was not recovered on Job #22-111 by this firm. The Lynch rebar was accepted this survey.

RANDOM ERRORS in measurement: This is considered to be a rural survey with an acceptable relative positional accuracy of 0.26 plus 200 parts per million.

THEORY OF LOCATION: The section, quarter and quarter quarter lines were established from the monuments recovered in the field and ties to previous surveys by this firm in Section 12. The centerline of Temple Road was established from deed record bearings and distance from Andry, Instrument # 2015R-1381 and mag nails recovered in the field. The new tracts were set as per the client's request.
