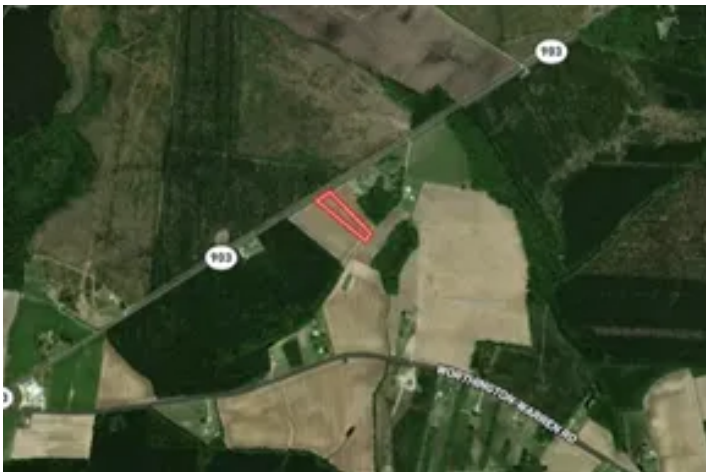

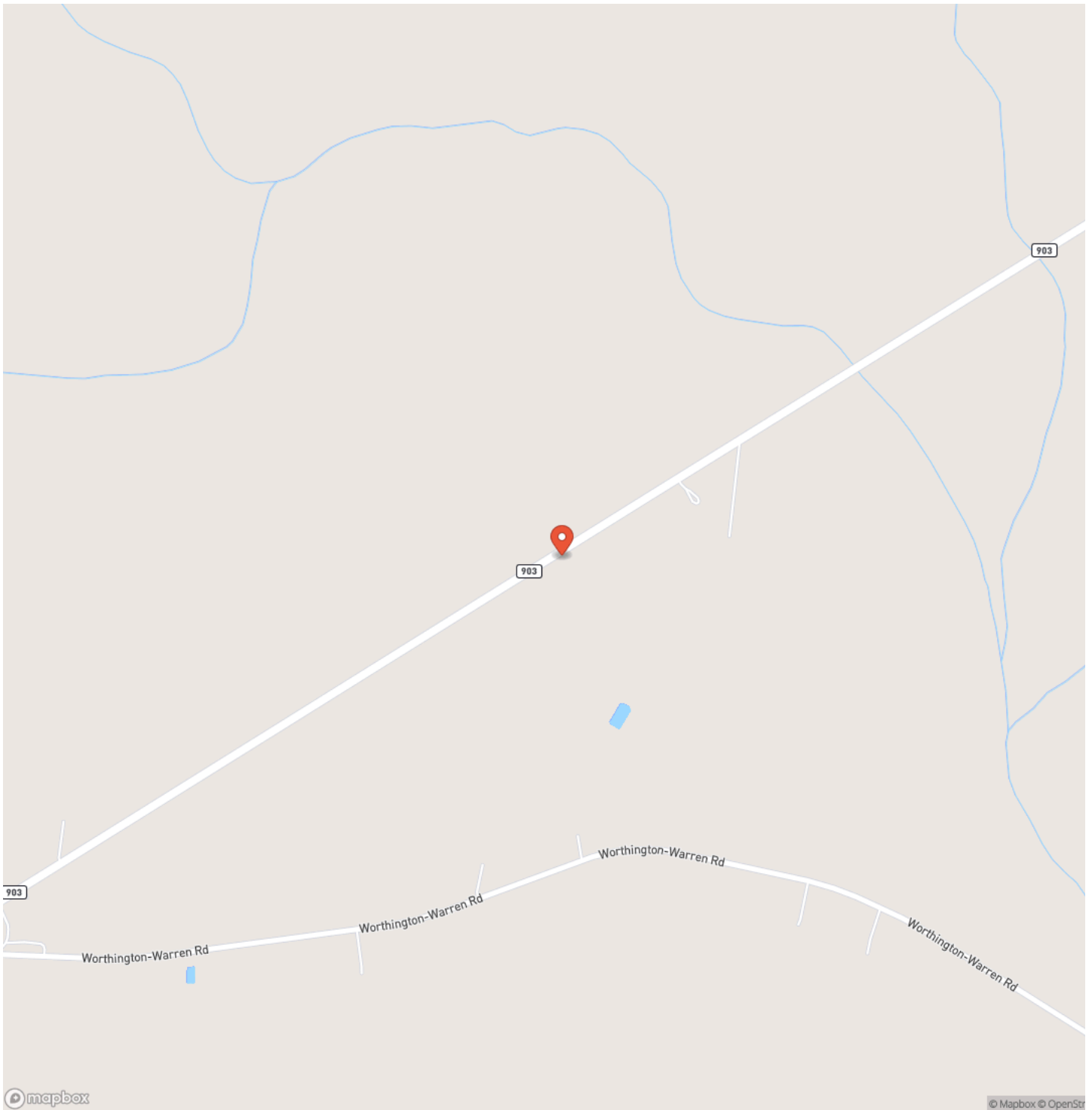

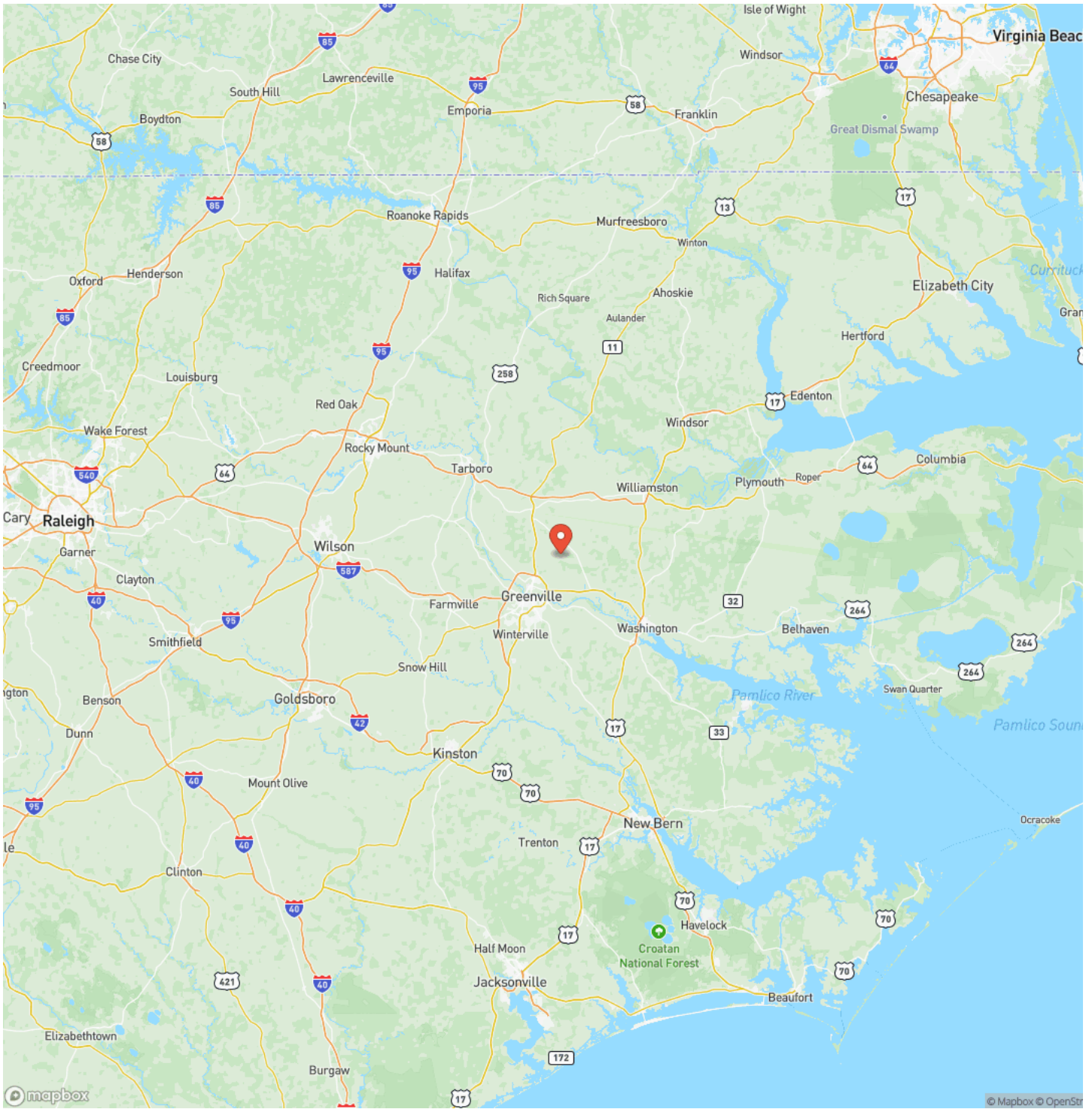


Locator Map

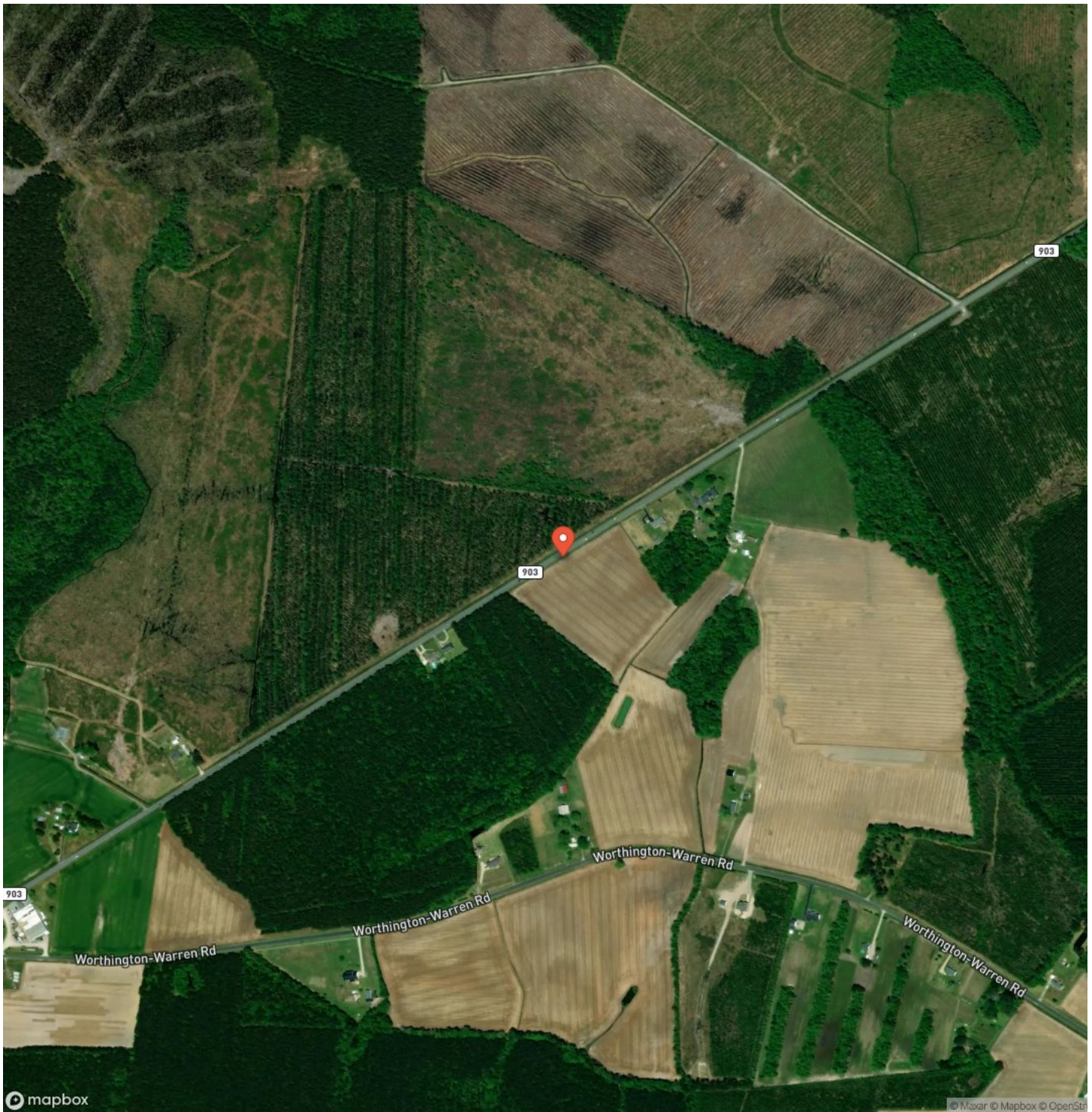
