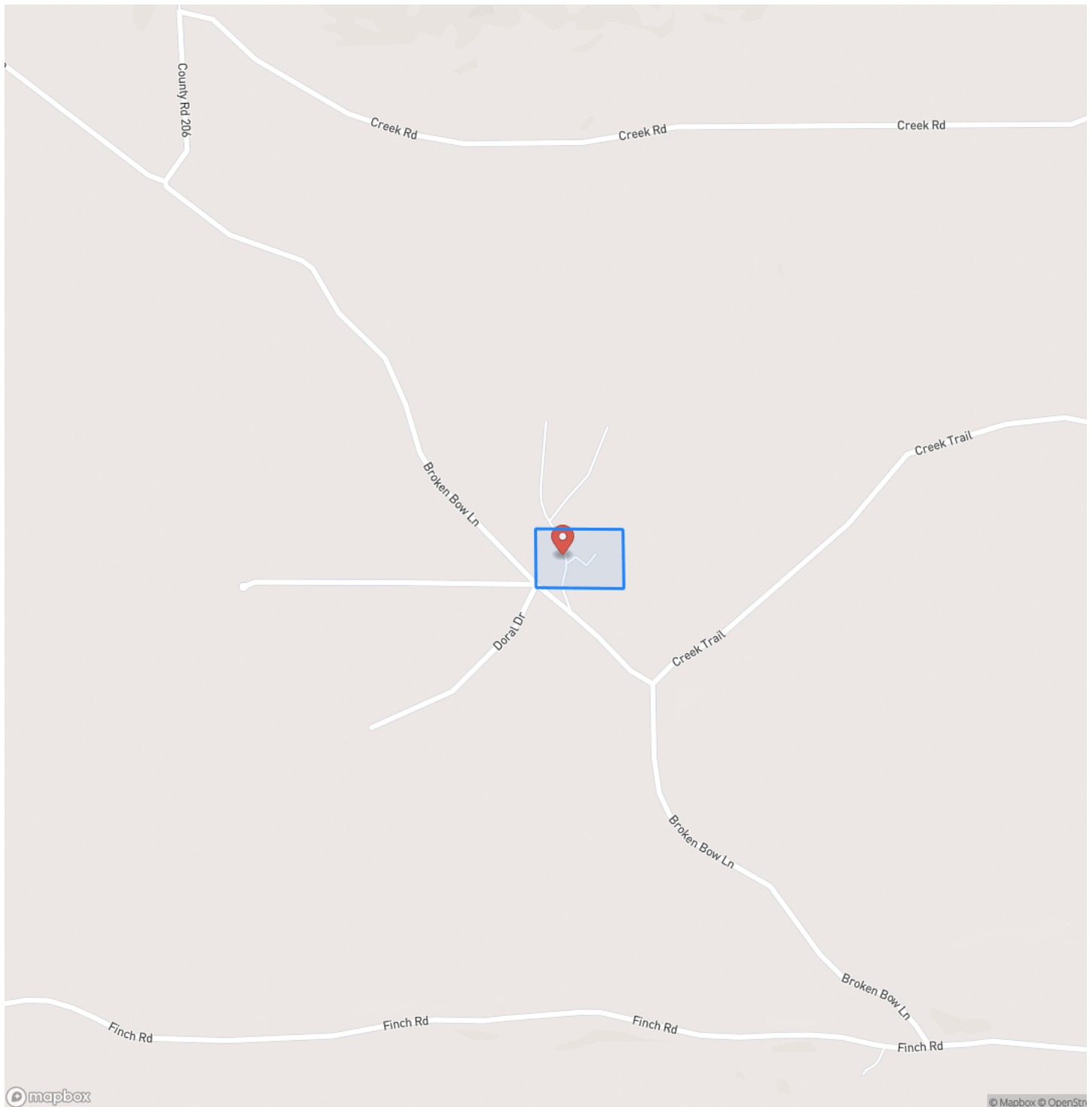




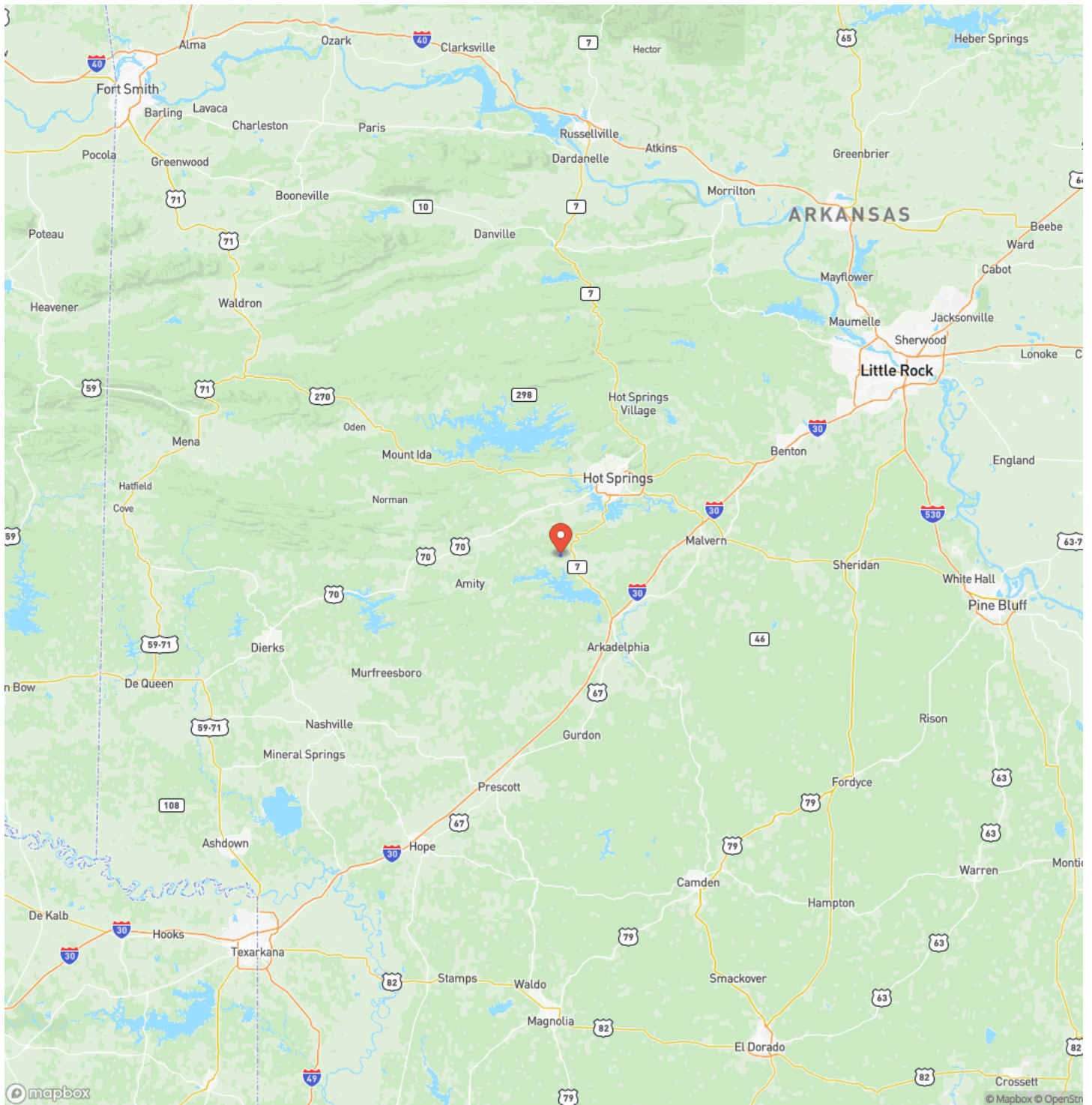




## Locator Map

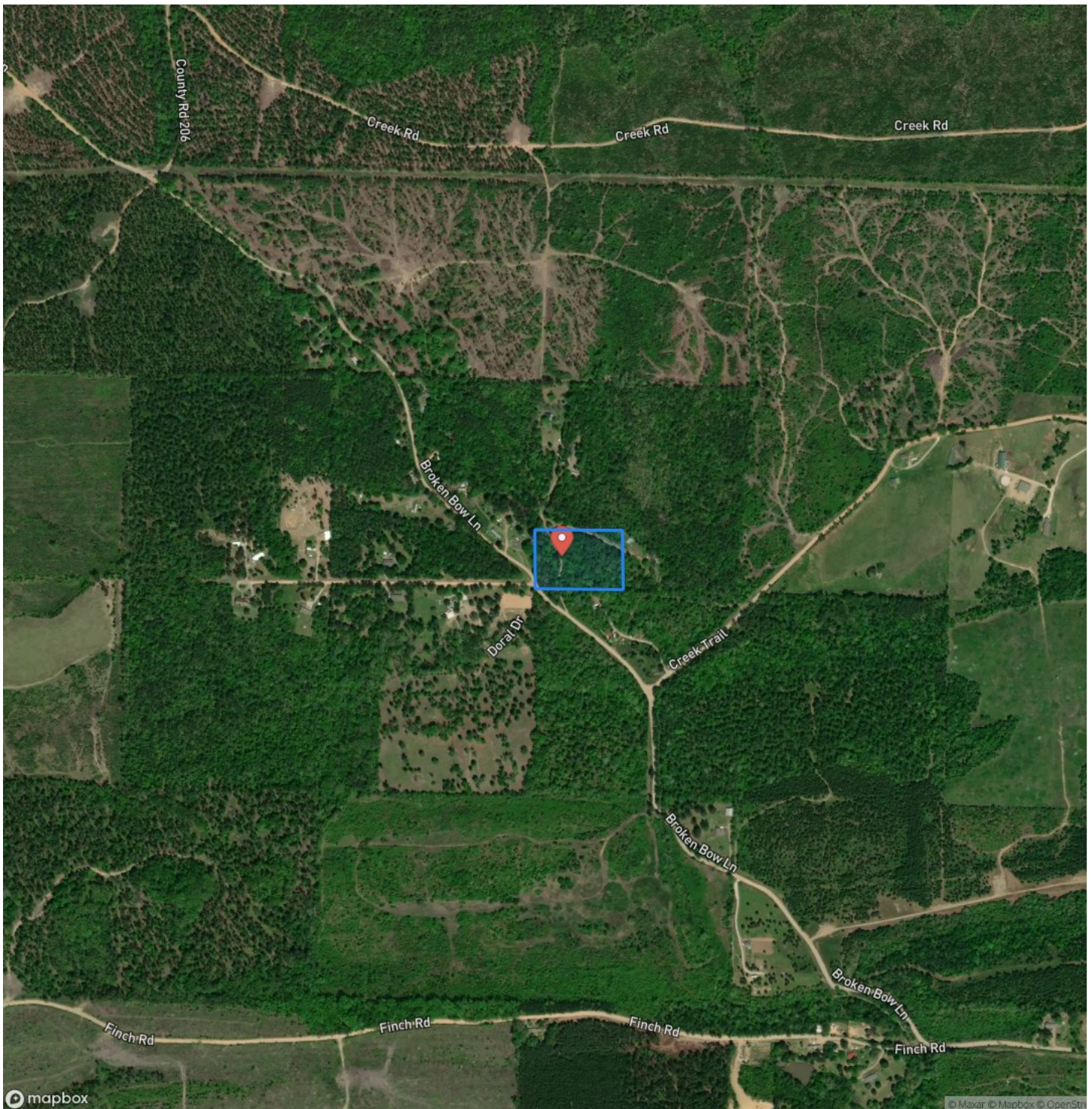
