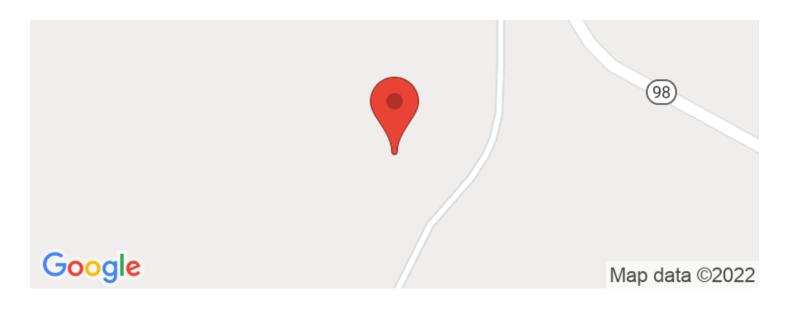








Locator Maps
