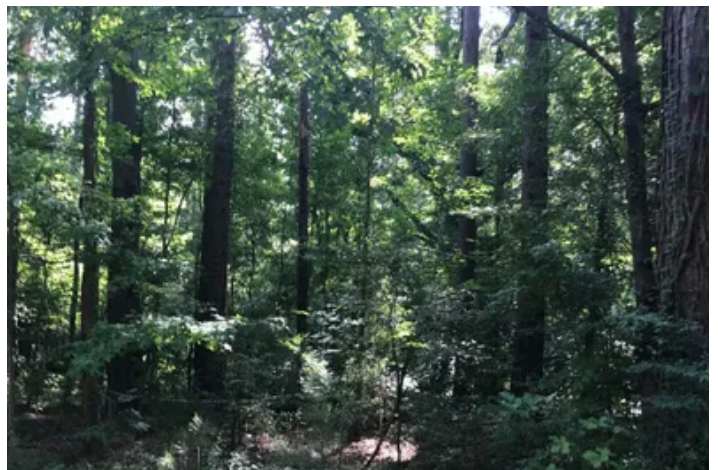

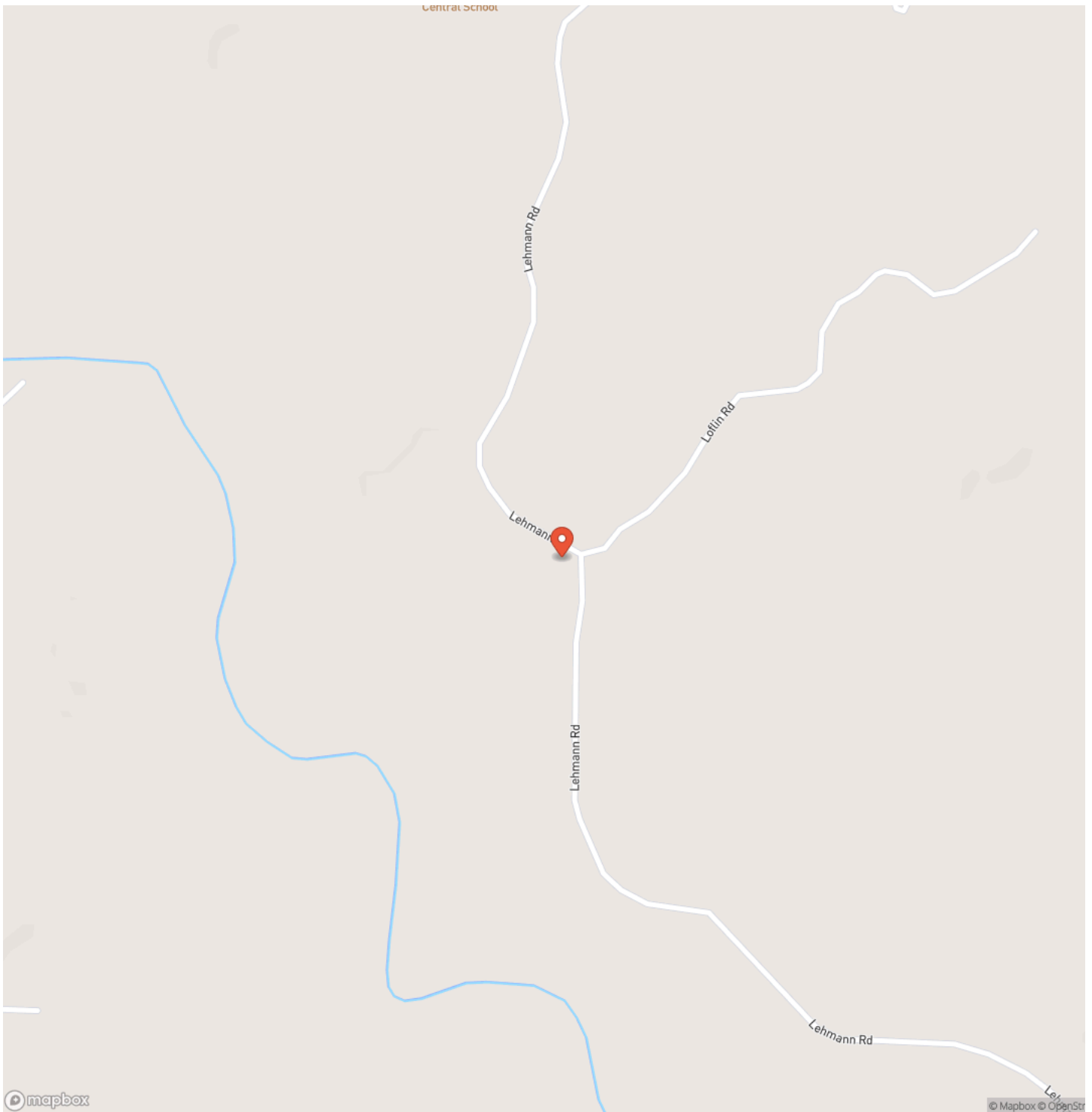
PROPERTY DESCRIPTION

The potential for this 295 acre tract in the heart of preferred Franklin County hunting and timber land on Lehmann Road (west boundary) in the Oldenburg community is virtually untapped. It is comprised of a nice mixed pine/hardwood timber stand with rolling hills and interspersed hardwood drains. It offers a nice concealed camp/potential housesite (as you prefer) with electricity and county water already on site. The abandoned Loflin Road (former county road) provides access to the camp and beyond completely traversing a portion of the tract in a SW-NE direction (see attached aerial and other maps). Three (3) ponds are located on the tract; however, one (1) has a breached dam (these can also be seen from the attached aerial and other maps). There are several small food plots located on the tract with two (2) being old oil well drillsites that were plugged as "dryholes" and never produced (see attached oil map). The turkeys and deer are there, but achieving the full potential for both is left strictly to the imagination and ingenuity of the new owner. 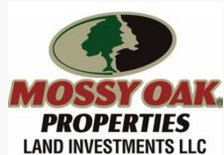
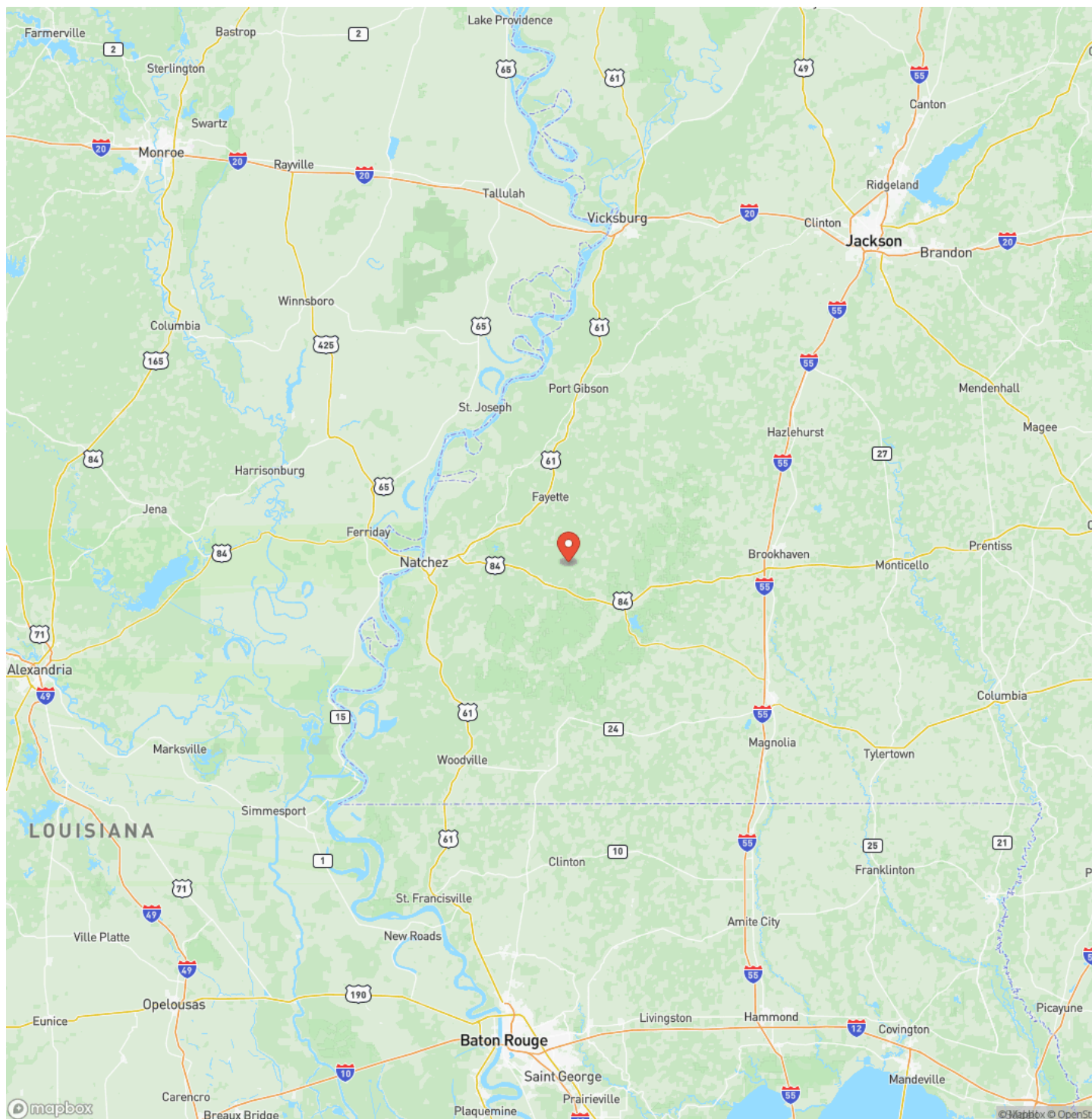
