- Potential pond sites

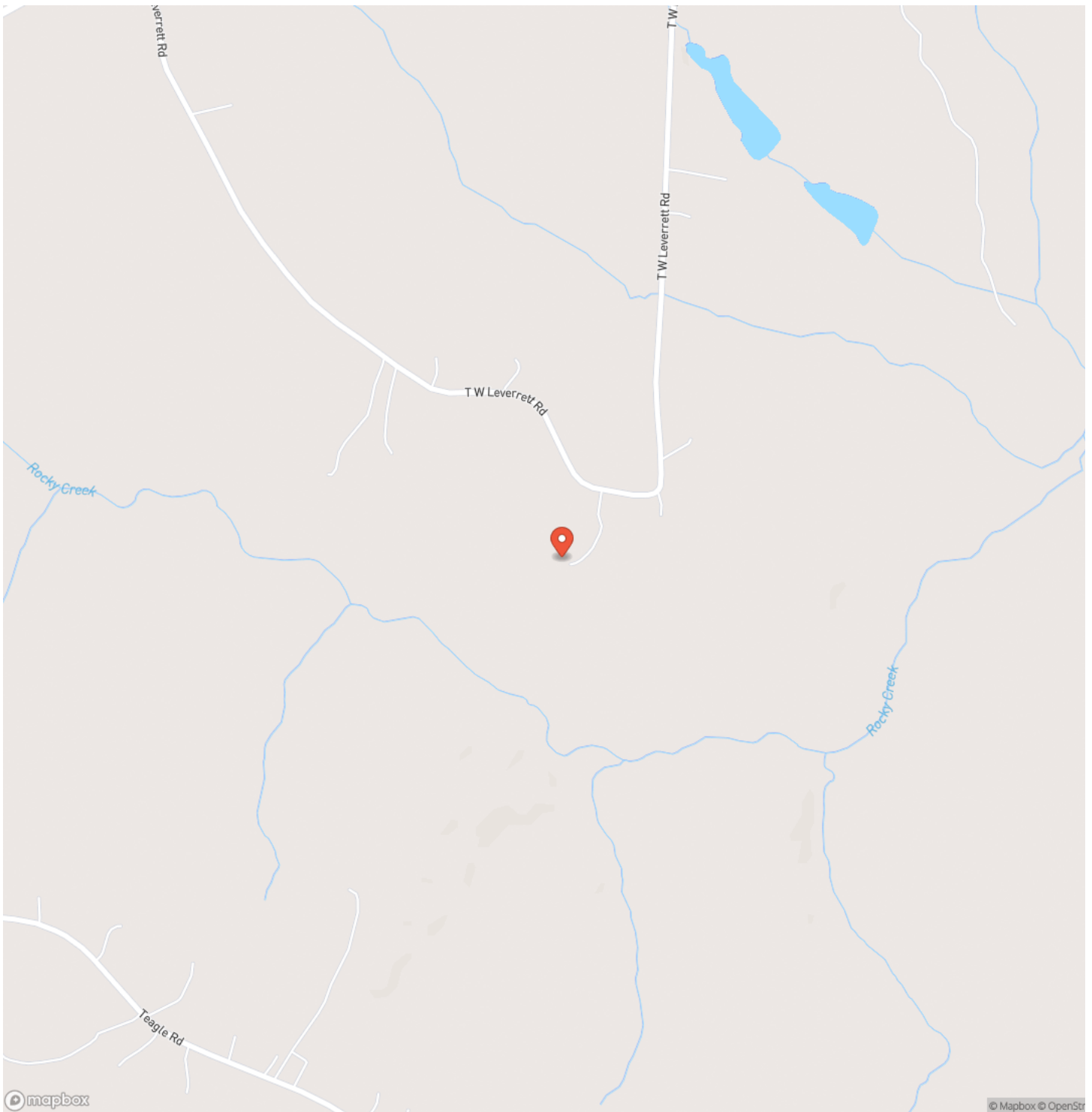

- I-75: less than 15 min

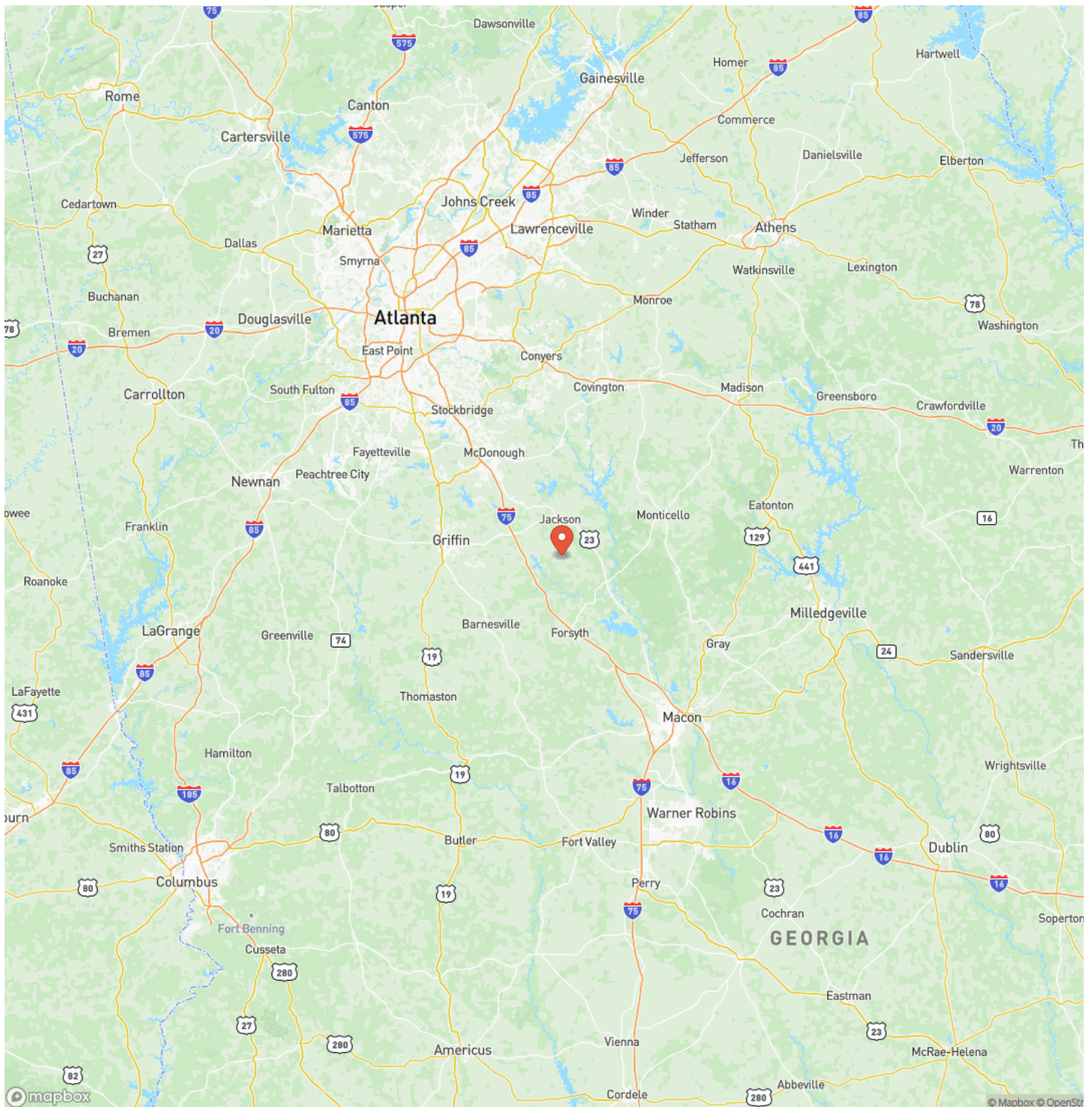
