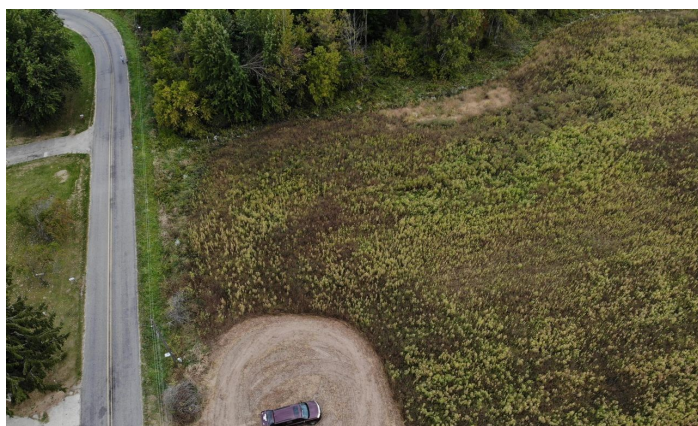

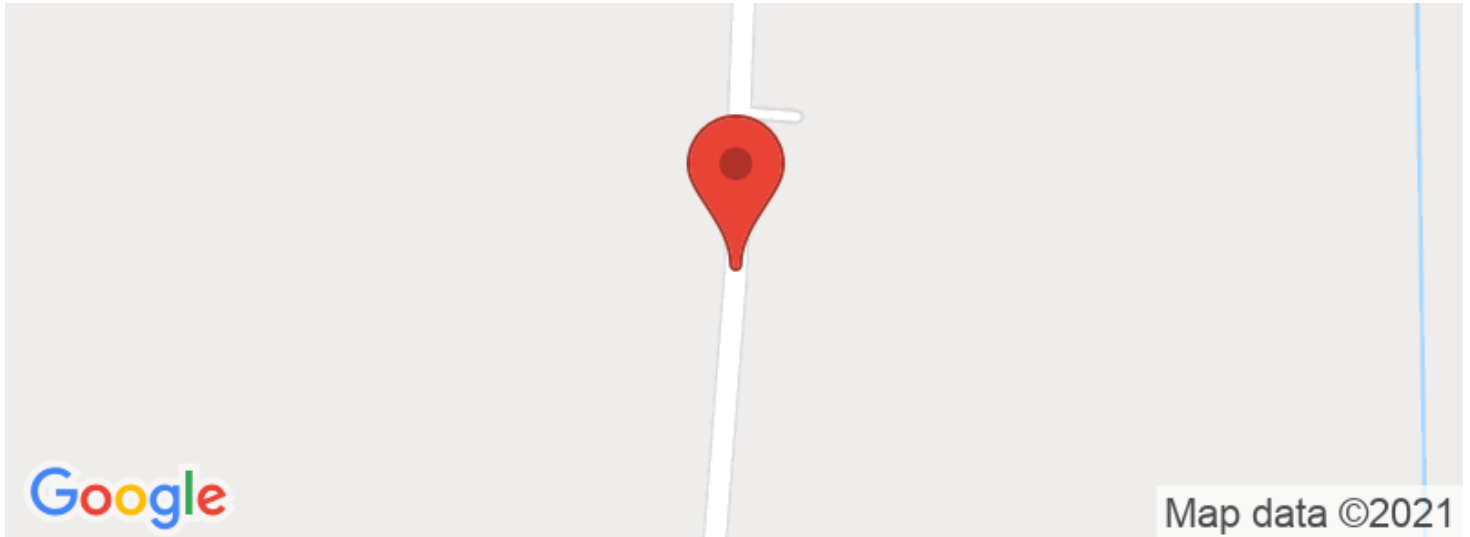

## Locator Maps

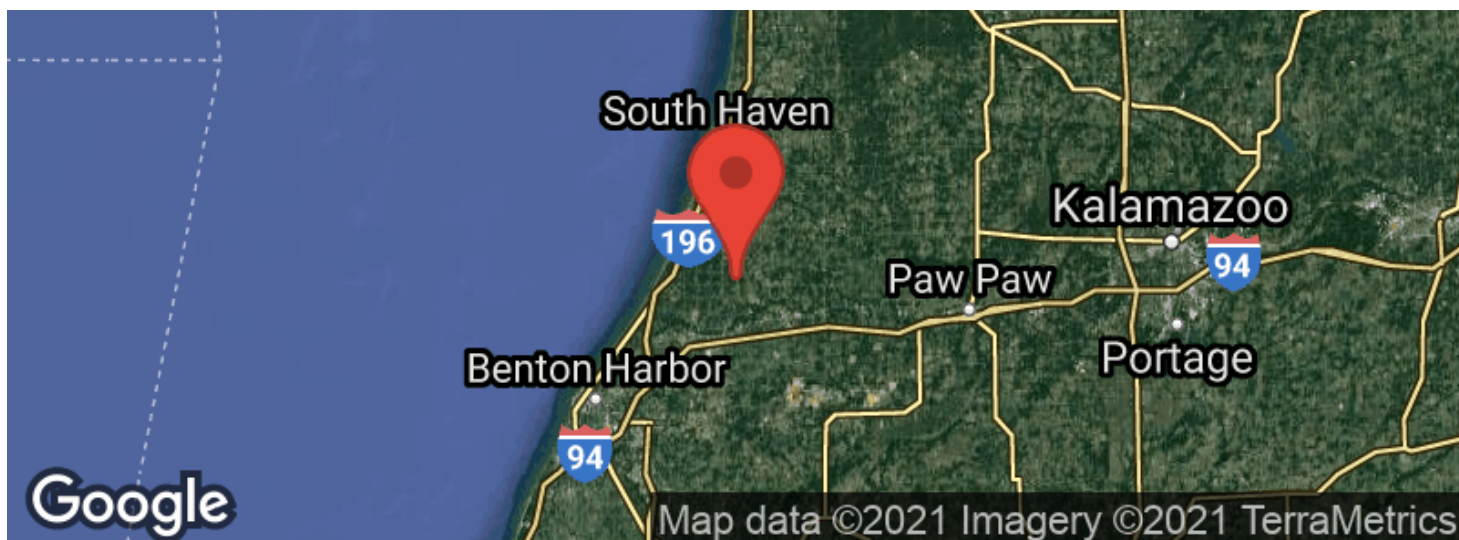
