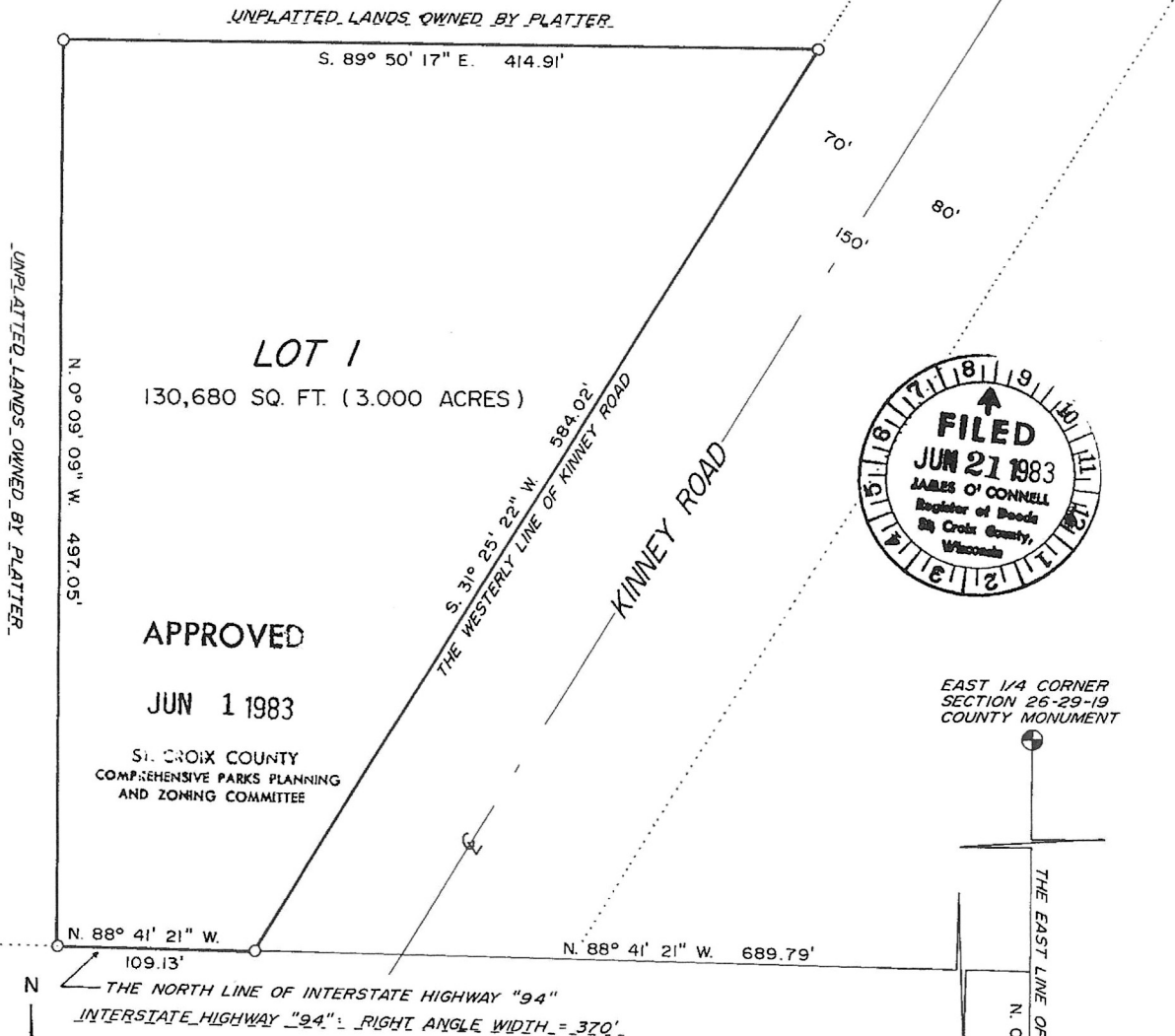

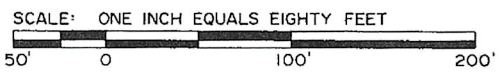

SURVEYORS CERTIFICATE

I, Allen C. Nyhagen, a registered Land Surveyor, hereby certify that by the direction of Orlow A. Widvey, I have surveyed, described and mapped the land parcel which is represented by this Certified Survey Map; that the exterior boundary of the land parcel surveyed and mapped is described as follows:

A parcel of land located in part of the SE 1/4 of the SE 1/4 of Section 26, T 29 N, R 19 W, Town of Hudson, St. Croix County Wisconsin, further described as follows:

Commencing at the SE corner of Section 26; thence N 0°-00'-00" E along the East line of the SE 1/4 of said Section 26, 124.16 feet; thence N 88°-41'-21" W, 689.79 feet to the north R/W line of I-94 and the point of beginning of this description; thence N 88°-41'-21" W, along said I-94 R/W line, 109.13 feet; thence N 0°-09'-09" W, 497.05 feet; thence S 89°-50'-17" E, 414.91 feet to the westerly R/W line of Kinney Road; thence S 31°-25'-22" W, along the westerly R/W line of Kinney Road, 584.02 feet to the point of beginning.
