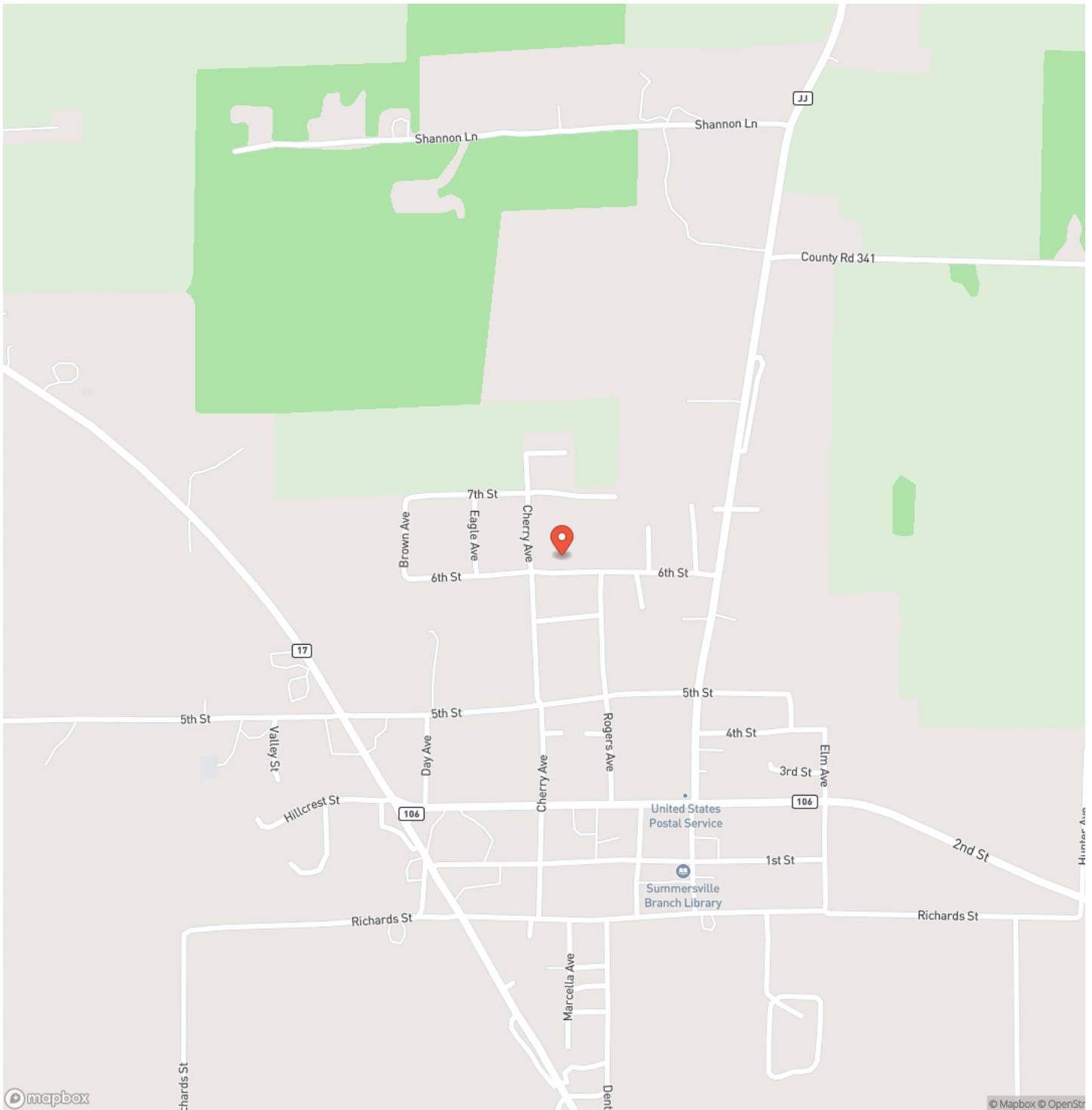
PROPERTY DESCRIPTION

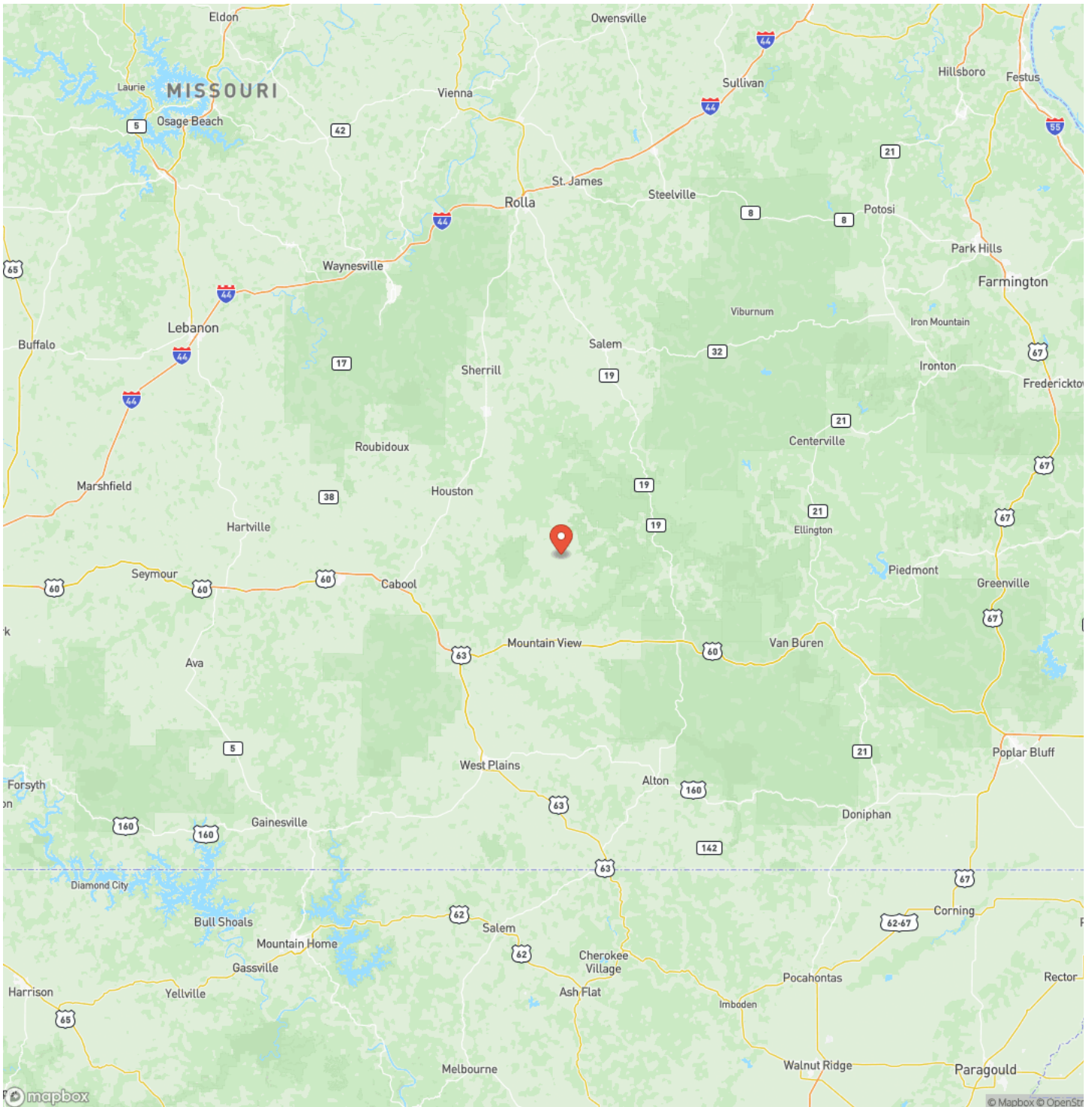


Locator Map
