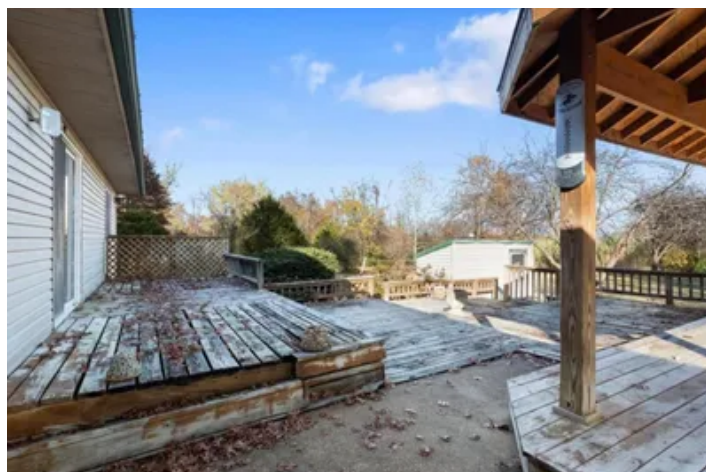

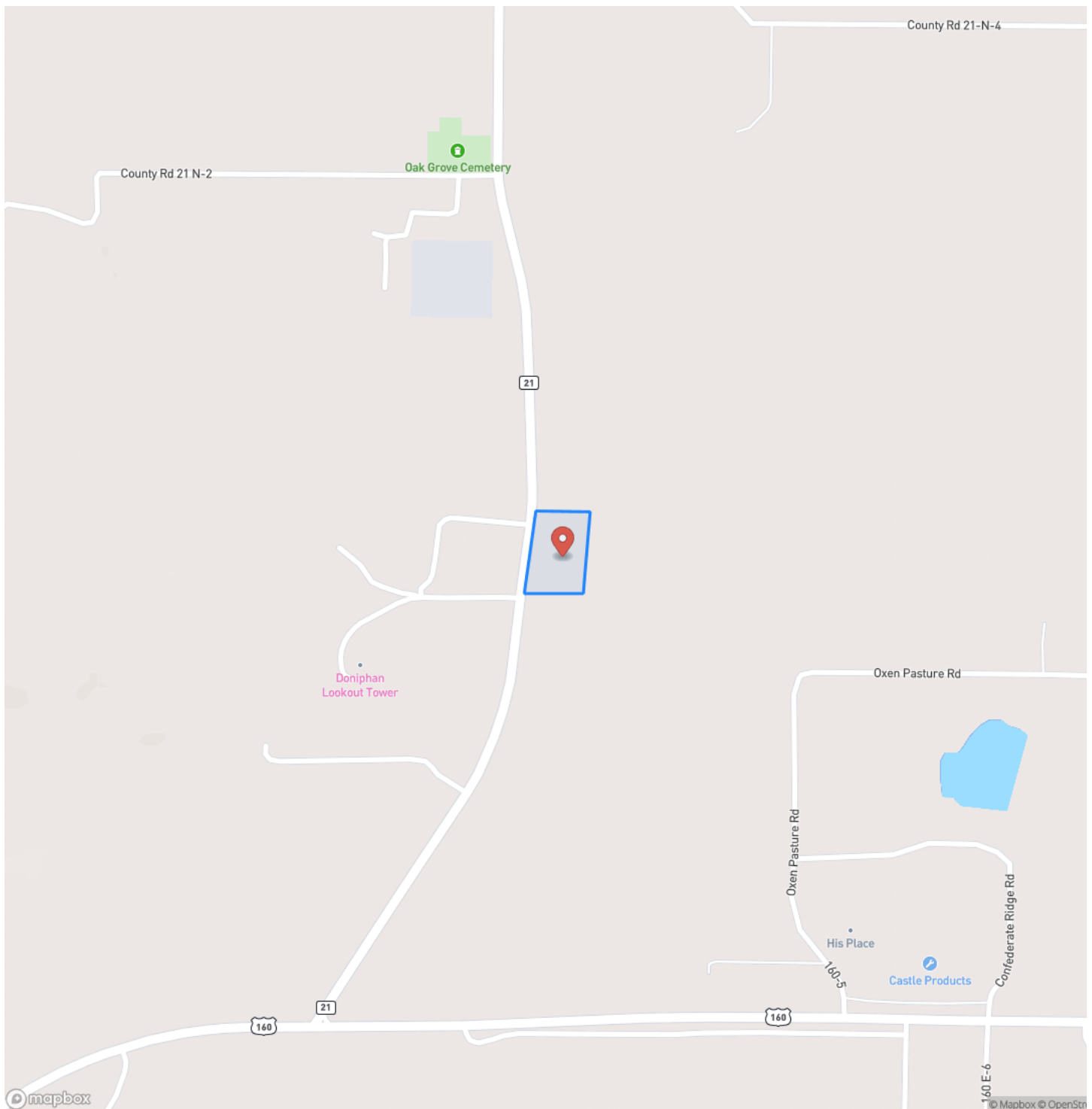

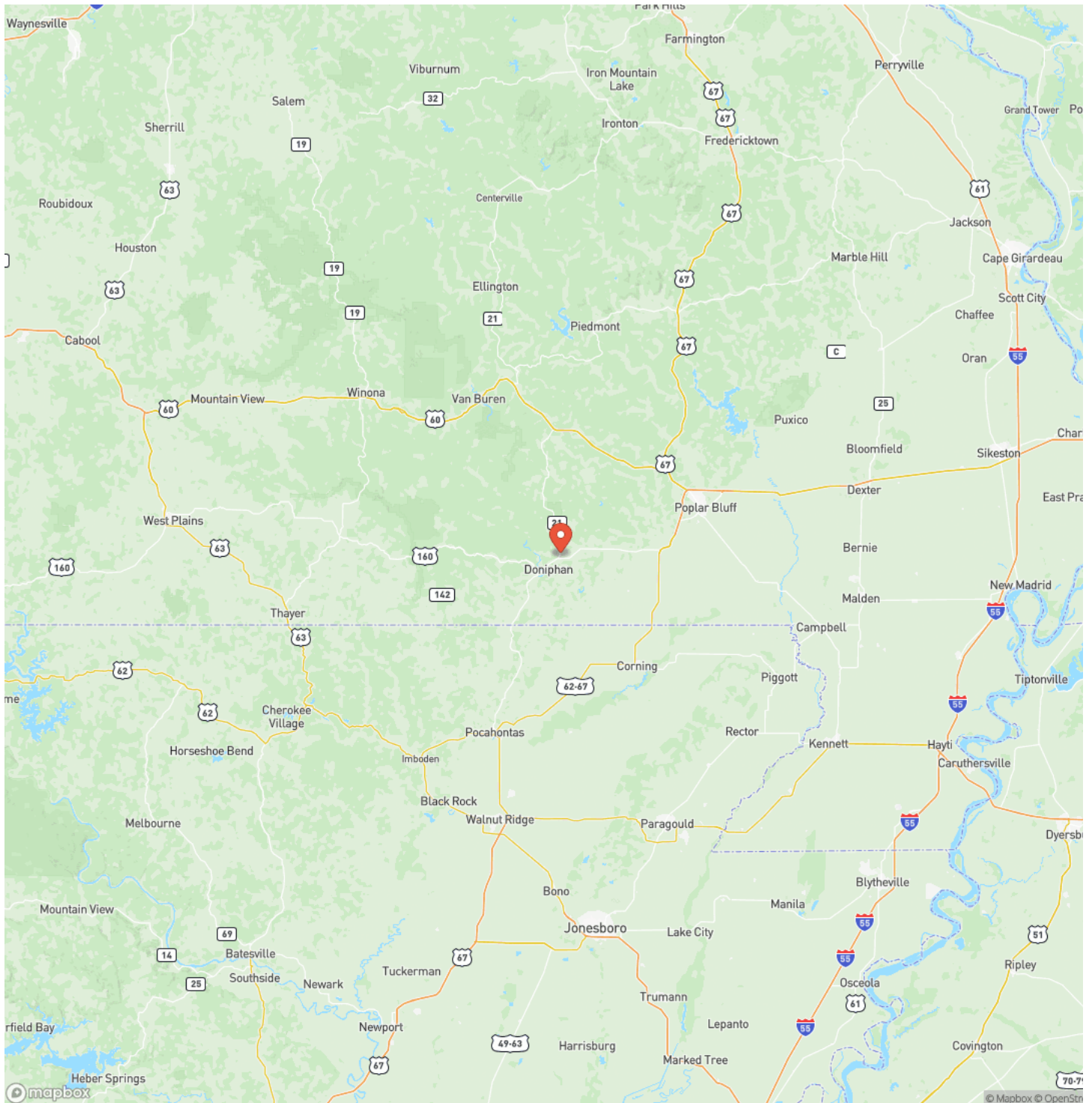

Locator Map



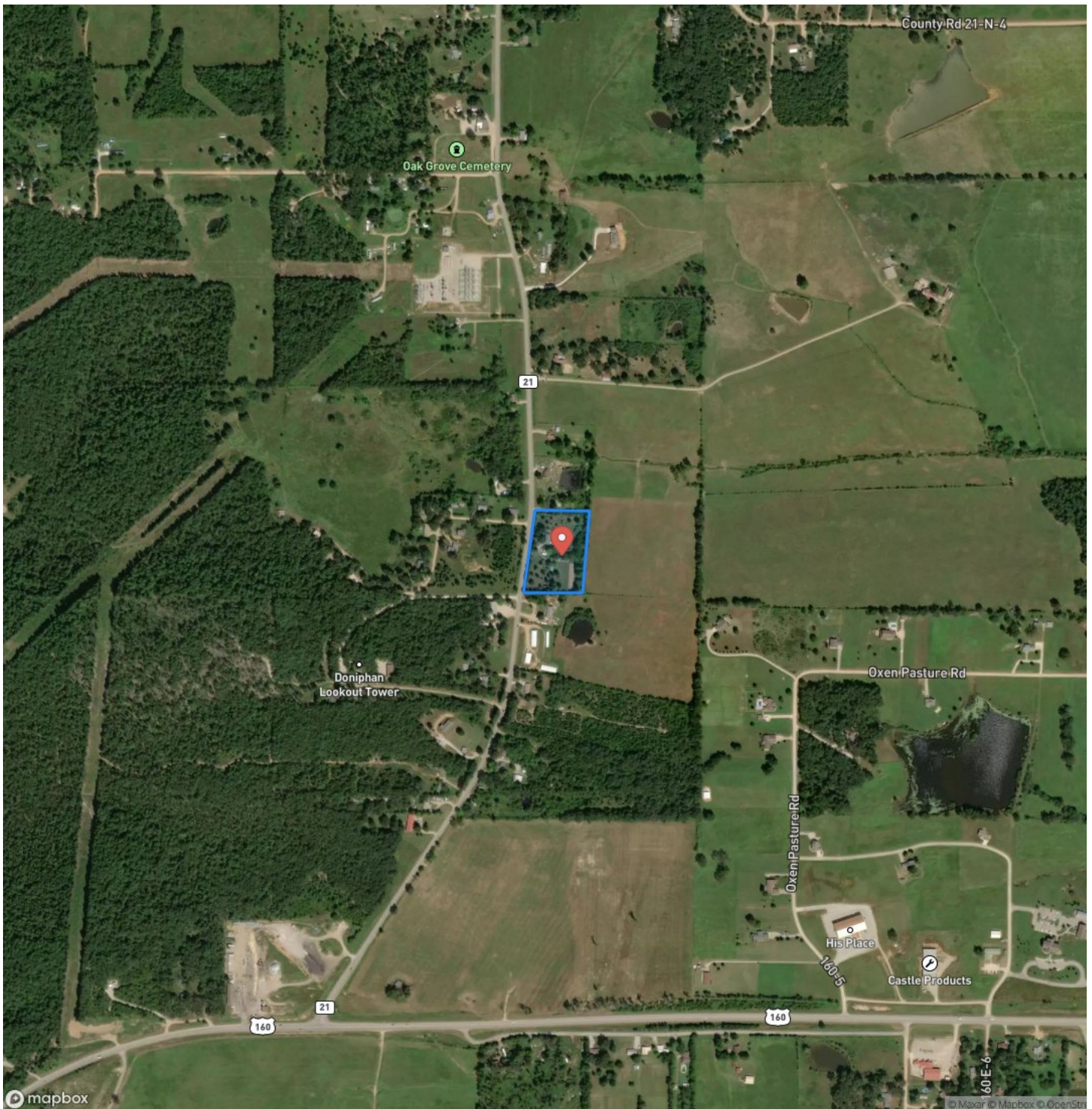
