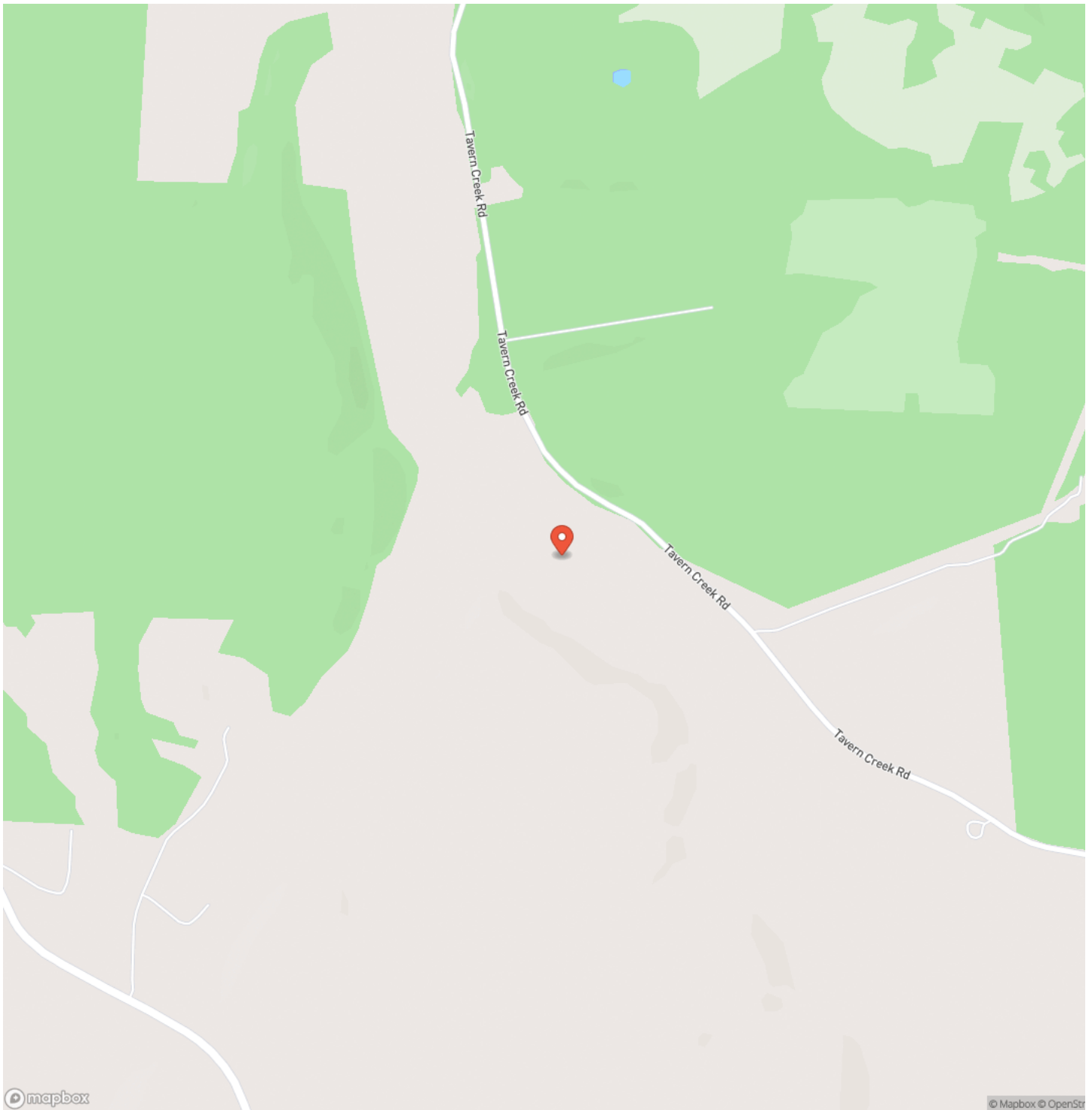
PROPERTY DESCRIPTION

170ac +/- with live water, pasture and woods for sale in Miller County, Missouri - Located Southeast of Iberia on Tavern Creek Road, this rolling Ozark ground boasts approx. 1300ft of live creek bubbling flowing gently along the edge of the meadow. Mature hardwoods with the occasional pine stand cover the ridges and draws, providing an excellent variety of bedding and habitat for the abundance of wildlife that make this their home. Wild turkey and whitetail deer are plentiful, as this farm has not been hunted in many years. Enjoy approx. 23 acres of hay pasture, while an additional 6 acres could be reclaimed for additional grazing duties, or converted into a productive food plot. Electricity runs through the meadow and there are multiple options for building sites scattered throughout the landscape, offering opportunities for a home place or a hidden getaway. Bottomland soils are gravel and silt loams. Part of a larger parcel - final acreage to be determined by a survey.

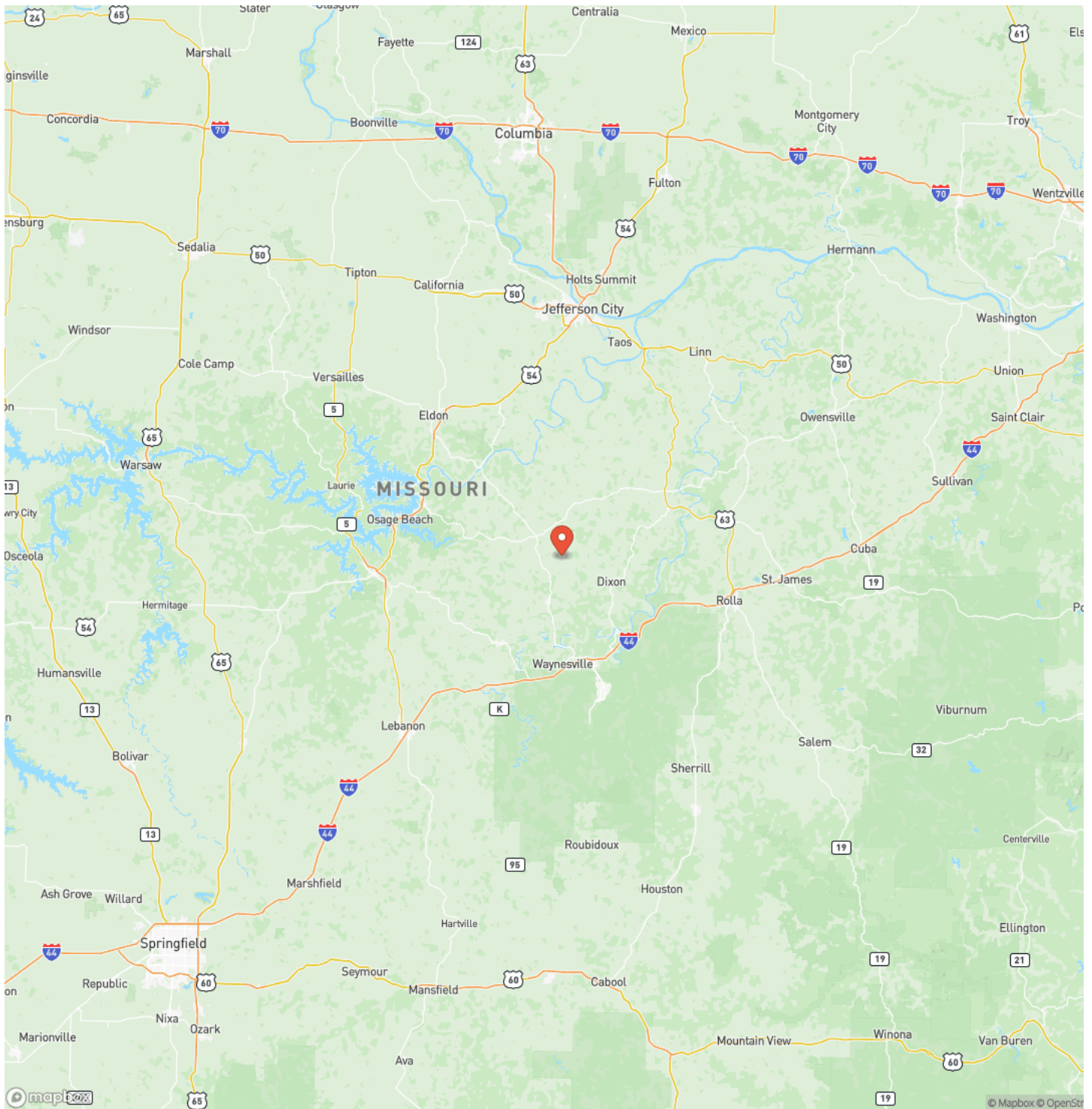


Locator Map
