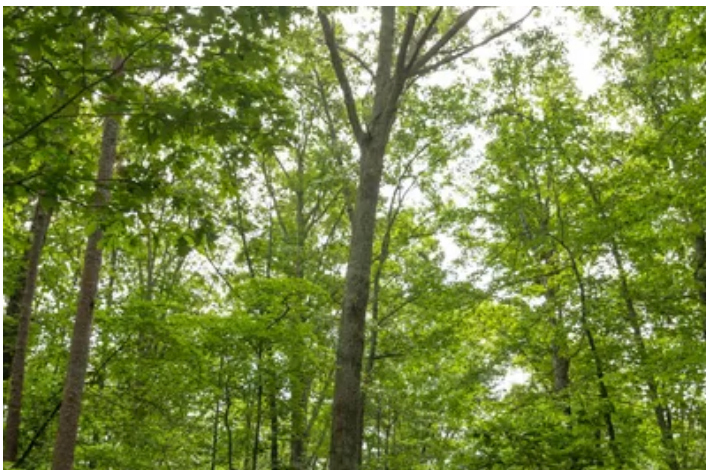

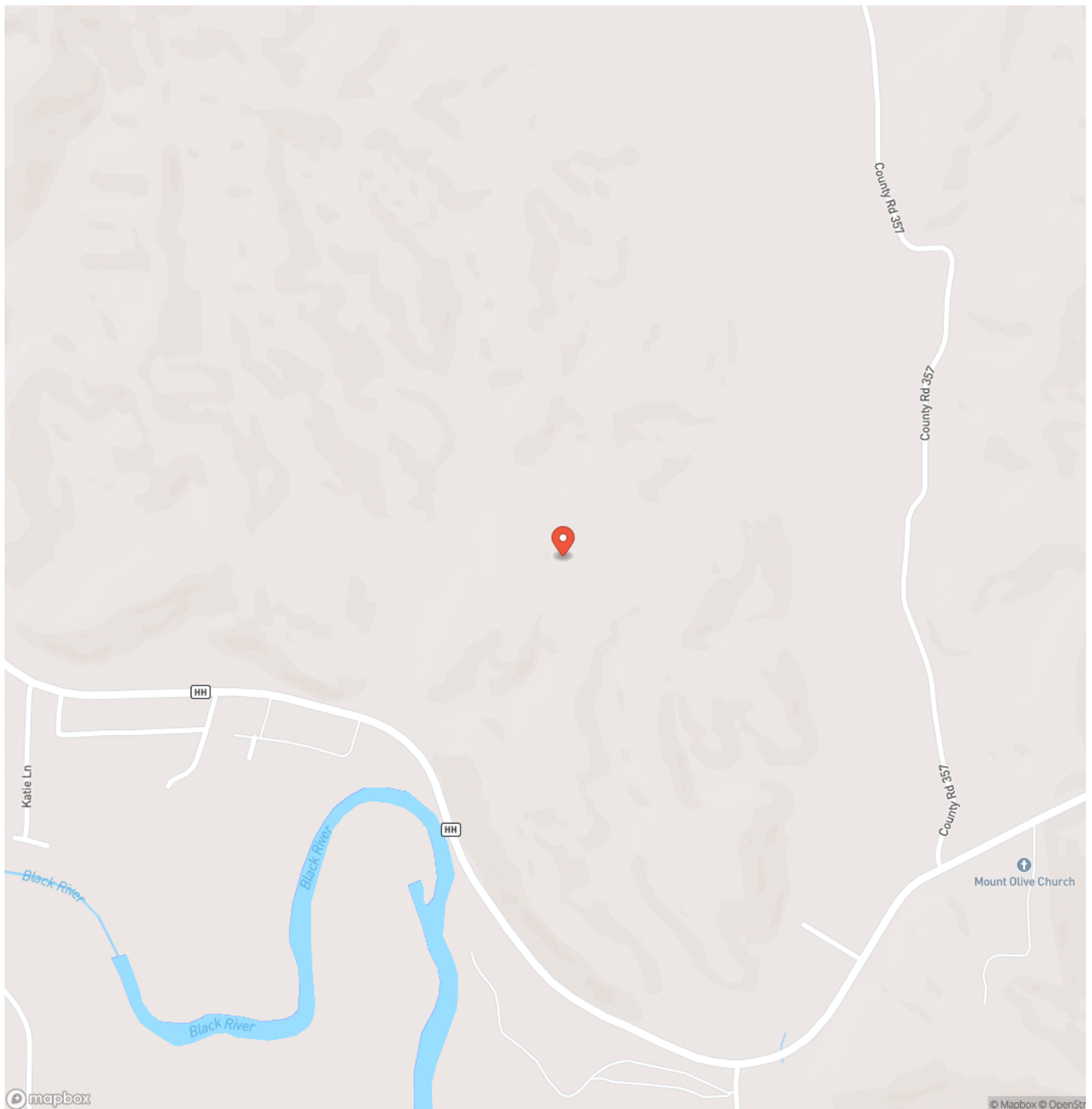

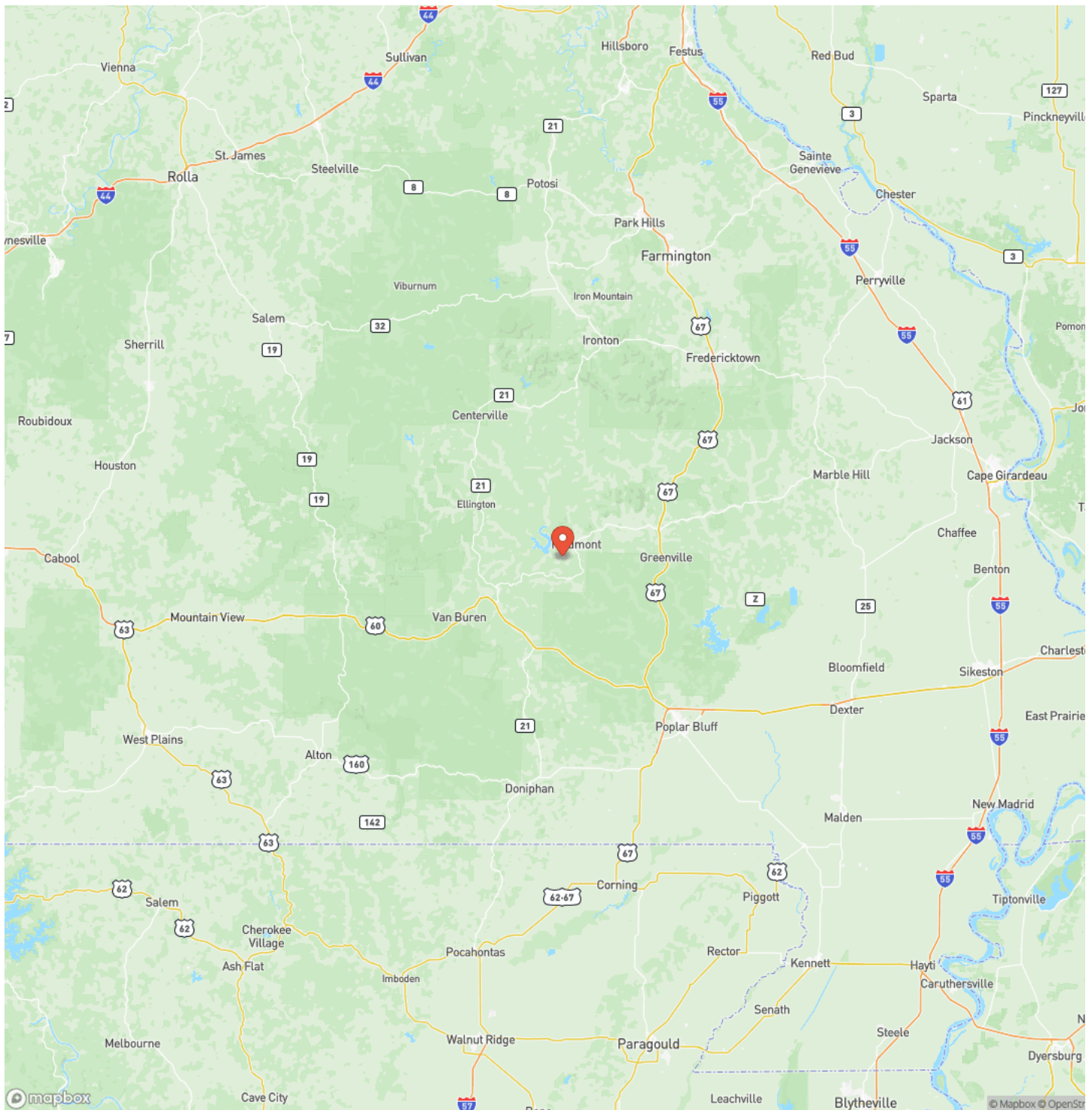


Locator Map
