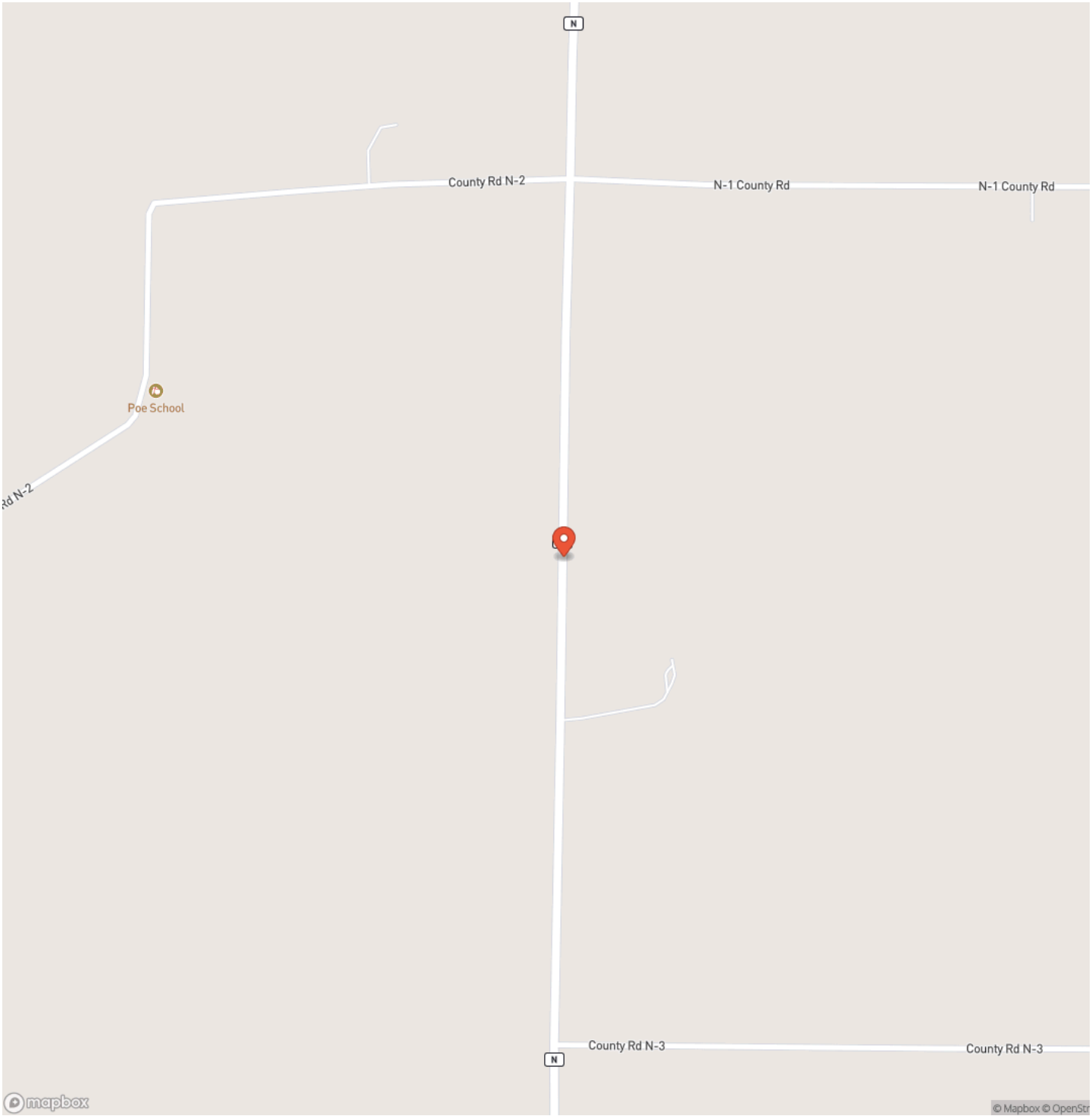

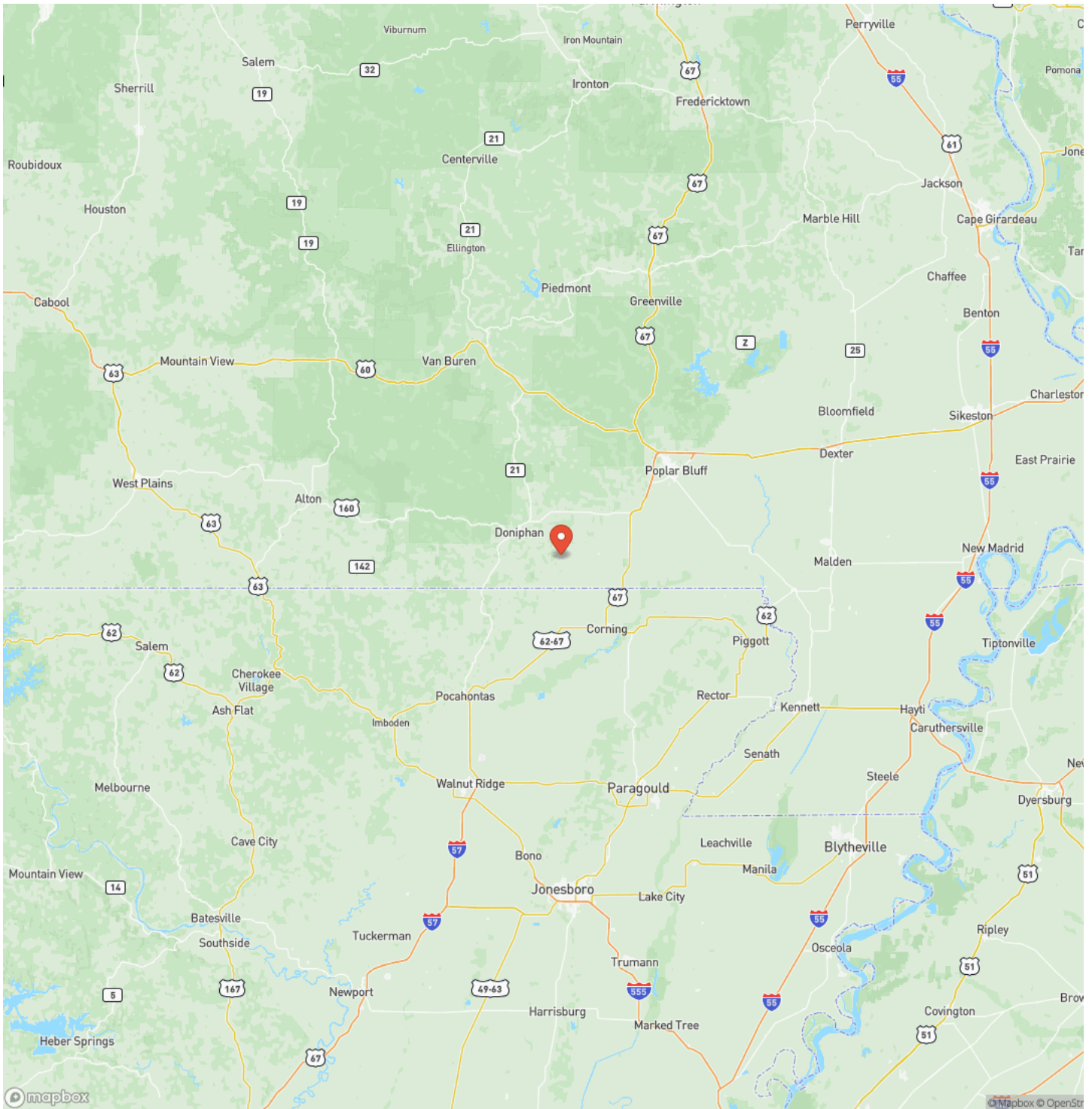


Locator Map
